#### **EXPLANATORY STATEMENT**

(Pursuant to Section 102(1) of the Companies Act, 2013 and Secretarial Standard II on General Meetings)

#### **ITEM NO. 1 & 2**

Pursuant to Section 180(1)(c) and 180 (1) (a) of the Companies Act 2013, the members of the Company had at Annual General Meeting held on September 26, 2022, authorised the Board of Directors (which term shall be deemed to include any Committee of the Board) to borrow money (ies) on behalf of the Company and for creation of charge on any assets or undertaking of the Company as security in favour of lending agencies for a sum not exceeding Rs. 250 Crores (Rupees Two Hundred and Fifty Crores Only).

The above limits were apart from temporary loans obtained or to be obtained from the Company's bankers in the ordinary course of business.

In the year 2022, when the borrowing limits were increased to Rs. 250 Crores the revenue achieved was Rs. 184.80 Crores whereas in current financial year, revenue of the company was Rs. 267.52 Crores which is a growth of around 44% based on our estimation we are targeting compounded growth in the next 3 to 4 years. Apart from this, Megastar Foods Limited has to support its subsidiaries for their business operations hence we are proposing to increase our borrowing limits from Rs. 250 Crores to Rs. 500 Crores for our capex requirements, working capital and investments needs of the business.

The Company may be further required to borrow money, either secured or unsecured, from the banks/financial institutions/other body corporate, from time to time, and to pledge, mortgage, hypothecate and/or charge any or all of the movable and immovable properties of the company and/or whole or part of the undertaking of the Company.

The Board of Directors of the Company proposes to increase the limits to borrow money and to secure such borrowings by pledging, mortgaging, hypothecating the movable or immovable properties of the Company amounting upto Rs. 500 Crores (Rupees Five Hundred Crores). The above limit is apart from temporary loans obtained or to be obtained from the Company's bankers in the ordinary course of business.

It is therefore proposed to obtain fresh approval of members by Special Resolutions under Sections 180 (1) (a) and 180 (1)(c) of the Companies Act, 2013 to enable the Board of Directors (which term shall be deemed to include any Committee of the Board) to borrow money and to mortgage and/or create a charge on any of the movable and/or immovable properties and/or the whole or any part of the undertaking(s) of the Company to secure its borrowings upto a sum not exceeding Rs. 500 Crores (Rupees Five Hundred Crores only), which may exceed the aggregate of the paid-up share capital, free reserves and security premium of the Company.

The above limit is apart from temporary loans obtained or to be obtained from the Company's bankers in the ordinary course of business.
