Dear Sir,

Pursuant to SEBI circulars SEBI/HO/CFD/CMD1/CIR/P/2020/38 dated March 19, 2020 and SEBI/HO/CFD/CMD1/CIR/P/2020/106 dated June 24, 2020 wherein extension was granted for submission of financial results for the quarter/half year/financial year ended March 31, 2020 until June 30, 2020 and thereafter July 31, 2020 respectively due to the continuing impact of the COVID 19 pandemic.

We would like to submit that due to ongoing pandemic situation in Kanpur as well and the resultant lockdowns being imposed at the local level by the administration (the recent one being from July 21 to July 31) in 10 Police station jurisdictions which also covers the Arya Nagar/Swaroop Nagar area wherein the Registered Office of the Company is situated, the audit process was disturbed and could not be completed. Moreover, the statutory auditors of the Company are also from Jaipur, Rajasthan which is again a severely affected city.

While all the possible efforts have been made to ensure that the audit process is completed on time and the financial results are submitted within prescribed period, however, the same could not be completed as explained aforesaid. Hence, barring unforeseen circumstances, the Company would make all net efforts to complete exercise of financial results finalization within a month. Therefore, we would like to inform the Exchange that the company will publish its audited financial results for quarter/half year/financial year ended March 31, 2020 on or before August 31, 2020.

Therefore, we humbly pray to take note of our decision to announce our audited financial results for quarter/half year/financial year ended March 31, 2020 on or before August 31, 2020.
