This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes hold equity shares of your Company.

ICICI Prudential Value Fund - Series 8 had purchased 50,668 equity shares of your company respectively on November 21, 2019. As a result of the aforesaid transaction, the shareholding of the above mentioned entity has increased by more than 2% as compared to the previous disclosure made on June 24, 2015 for 6.46%.

As of the last reporting dated June 24, 2015, the Fund and various other entities were stated as 'persons acting in concert' on account of sharing of common system. However, with effect from August 06, 2018, the Fund and such other entities have phased out the existing common system and thus are not being considered as Persons Acting in concert on this account.

The objective of the purchase is from an investment perspective and not with the objective of seeking any controlling interest. However, the disclosures in this regard as required under Regulation 29(1) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 is enclosed herewith.
