With reference to above subject and in compliance with the SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015 we hereby submit the following outcome of the meeting of the Board of Director in its meeting held on 23<sup>rd</sup> November, 2020 at 4.30 P.M and concluded at 6.00 P.M.

1. Approval pursuant to provisions of the Companies Act, 2013 and SEBI (ICDR) Regulations, 2018 and subject to the approval of the shareholders, to create, issue, offer and allot upto 9,50,000 convertible warrants ("Warrants") to Chmapawat Investments and Consultants Private Limited, a promoter company, at a price of Rs.13.37 per warrant, which shall not be less than the minimum price arrived in accordance with Chapter VII of the SEBI (ICDR) Regulations, 2018 read with Section 62 of the Companies Act, 2013 as amended from time to time, with a right to the warrant holders to apply for and be allotted 1(one) equity share of the face value of Rs.10/- each of the Company at premium of Rs.3.37 per share for each warrant, within a period of 18 months from the date of allotment of the Warrant, aggregating to Rs.1,27,01,500/- to the Chmapawat Investments and Consultants Private Limited, a promoter company.

3. Adoption of Secretarial Audit Report Pursuant to section 204(1) of the Companies Act, 2013 and rule No. 9 of the Companies (Appointment and Remuneration Personnel) Rules, 2014 for year ended on 31<sup>st</sup> March, 2020.
4. 29<sup>th</sup> Annual General Meeting of the Company will be held on Wednesday, 23<sup>rd</sup> day of December, 2020 at 3.00 p.m. through video conferencing (VC).
