As mentioned above, Cimmco (BSE Scrip Code: 505230 and NSE Scrip Code: CIMMCO) stands amalgamated with the Company w.e.f. 01/04/2019 (the Appointed Date) and is not in existence now, the compliance reports/disclosures required for the quarter ended 30<sup>th</sup> September, 2020 and onwards of Cimmco are not being submitted to your Exchange. As both the Transferor Companies: Cimmco and TCPL stand amalgamated w.e.f. 01/04/2019 (the Appointed Date) upon the Scheme having become effective, this intimation can only be and is being issued only from the Transferee Company.
