District officials favouring Oreva, allege kin of victims

Rajkot: The Gujarat high court's directives for the rehabilitation of Morbi bridge collapse victims have not been properly implemented by the officials of the Morbi district collector's office, alleged kin of the victims through their association.

In a letter submitted to the Morbi collector recently, the association expressed concerns and claimed that employees of the collector's office were favouring Oreva Group, which has been ordered to rehabilitate the victims and their kin.

March 22, directed the district collector to provide a comprehensive report on the victims. However, the Morbi Tragedy Victims' Association, which represents the families of 112 victims, alleged that "As per the high court's order Oreva has to provide financial and medical help to the victims through the collector's office but the work of survey was not done properly."

The association also expressed concern saying, "The owners of the responsible company (Oreva) have political and financial dominance and we feel that they are making your people (officials of collectorate) work as per their interest in this matter by using their influence."

They urged the collector to adhere to the high court's order in letter and spirit and ensure that the officials work without any pressure or fear.

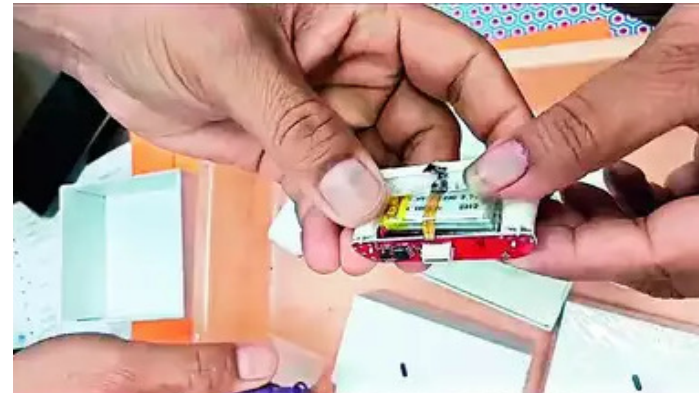
Special kids create voter awareness in Vadodara city

Dubai flyer caught carrying gold worth Rs 18L in airpods



SURAT: When thousands of passengers landing at or taking off from the Dubai Airport were worried for their lives due to the flooding there, a man was working on how to bring gold to India without paying duties.

He succeeded and his flight was among the last few to take off amid heavy rain.

However, he ran out of luck when he landed at Surat International Airport (SIA) on Wednesday. Customs officials recovered 240 gram of gold worth Rs 18 lakh from the passenger. The gold consignment included four pieces hidden in the cavity of airpod charging cases and one gold semicircular piece fixed

inside a mini juice blender. The recovered gold was of 24 carat purest form. In the juicer, the gold piece was fixed in place of a magnetic part.

In the airpod, the earplugs were inside the charging case and working. The man used the cavity inside the airpod charging cases and got gold

pieces prepared of accurate size.

After the arrival of the Dubai flight at Surat, the passenger was asked to step aside. The passenger did not disclose if he was carrying any valuables that attract import duty. The officials examined his luggage but failed to recover anything. Meanwhile, customs officials noticed packed boxes of airpod. The airpods were packed like brand new company packed boxes. On suspicion, the officials opened the boxes. There were earplugs inside the charging case. It again confused the officials but ultimately one more attempt helped them reveal gold bars when they separated the case cover from internal parts.

3 depts account for 80% of total RTI applications

Gandhinagar: Three departments of Gujarat govt — home, urban development and revenue — accounted for the bulk of applications received under the Right to Information (RTI) Act in 2022-23, according to a report tabled in the recently concluded session of the state assembly. Together, these three departments accounted for 79.36% of the applications received during the year. In absolute terms, state govt departments received 1,21,490 applications in 2022-23. Of these, home, urban development and revenue departments received 96,412 applications, said a Gujarat Information Commission (GIC) report. While the home department received 38,589 RTI applications, the urban development department received 33,841 applications and the revenue department,

23,982 applications. All the other departments together received 25,078 applications. Meanwhile, the number of appeals and complaints received by the GIC rose by 488 in 2022-23 from the previous year. Together, these three departments accounted for 79.36% of the applications received during the year. In absolute terms, state govt departments received 1,21,490 applications in 2022-23. Of these, home, urban development and revenue departments received 96,412 applications, said a Gujarat Information Commission (GIC) report. In all, 8,257 complaints and appeals were received by the commission in 2022-23 from 7,769 in 2021-22. The commission disposed of 6,853 cases, which included 5,902 appeals and 951 complaints, the report said.

CR misses 'vijay muhurat' as crowd swells in Navsari

SURAT: State BJP president and Navsari MP, CR Paatil, missed the 'vijay muhurat' of 12.39pm on Thursday after a massive show of strength that saw a large number of people flooding his roadshow to the collector's office in Navsari.

Paatil, who had won Navsari seat in 2019 with a staggering margin of 6.89 lakh votes, will file the nomination papers on Friday. Chief Minister Bhupendra Patel, BJP general secretary Ratnakar, finance minister Kanu Desai, and junior home minister Harsh Sanghavi were accompanying Paatil in the roadshow of that started from his campaign

office and passed through Circuit House, Lunsikui Ground, court complex, Juna Thana, Vivekanand Statue and Shivani Park to reach the collector office. Paatil was supposed to submit his papers at 12:39pm sharp. However, he could not reach in time "Paatil religiously follows the muhurt tradition of the Hindu faith. He believes such beliefs are important to get success," said a senior BJP leader. "As a large number of people converged on the roadshow route to greet Paatil, he could not reach the collector's office in time and missed the muhurt of 12.39 pm. We follow Hindu culture

and that's why the muhurt is important for us," said Narottam Patel, a BJP veteran and former minister. Jigar Jani, the priest who was supposed to perform rituals before the nomination form submission, confirmed that Paatil will file his papers on Friday. Chief Minister Bhupendra Patel, BJP general secretary Ratnakar, finance minister Kanu Desai, and junior home minister Harsh Sanghavi were accompanying Paatil in the roadshow of that started from his campaign office and passed through Circuit House, Lunsikui Ground, court complex, Juna Thana, Vivekanand Statue and Shivani Park to reach the collector office.

Unseasonal rain lashes Kutch, Saurashtra

Rajkot: Unseasonal rain was recorded in Saurashtra and Kutch region on Sunday, under the influence of induced low-pressure area over south-west Rajasthan and its neighbourhood with the associated cyclonic circulation.

Anjar town in Kutch recorded 56mm of rainfall which led to waterlogging in many streets. The sudden change in climatic conditions may have brought relief from the heat, but it raised concerns over the impact of the unseasonal rain on the mango crop as well as other standing crops in the farms across the Kutch and Saurashtra region.

Farmers were also worried about their produce that was lying in the market yards across the region.

According to the IMD forecast, light thunderstorm with lightning and surface wind speed of 30kmph to 40 kmph accompanied by light rain was likely for the next two days at isolated places in Banaskantha, Bharuch, Surat, Bhavnagar, Amreli, Gir Somnath, Kutch and in Diu.

"Discomf conditions due to hot and humid air very likely to prevail over coastal areas of Gujarat region and Saurashtra and Kutch for next three days," the IMD bulletin stated. Kutch district administration stated that besides Anjar, rain was recorded in Rapar, Deshalpar, Mankuva and other parts of the district.

Light showers were also witnessed in Morbi and Halvad towns. Dhari taluka in Amreli and rural areas of Gir Somnath district also recorded a change in weather for the second consecutive day.

Rain with thunderstorms was recorded in Bhanvad taluka of Devbhumi Dwarka district. In Jasdian taluka of Rajkot, there was a sudden change in weather on Sunday afternoon with heavy gusts followed by rain and thunderstorms.

Woman hurt as guard closes society gate, complaint filed

Ahmedabad: A 50-year-old man from the Shahibaug area of the city on Sunday filed a complaint with police alleging that his wife suffered injuries on her head and shoulder when a security guard suddenly closed a remote operated gate at their residential society when she was riding her scooter.

Rajesh Jain, who works as a share broker, said in his FIR with Shahibaug police that he along with his wife Kajal and their two children live at Orchid Green society in Girdharnagar locality of Shahibaug.

Rajesh alleged in the FIR that his society's chairman Kesarimal Jain and secretary Naresh Shah had instructed the society's watchman Shailesh Patni to keep watch on his family. He alleged that Kesarimal and Shah were harassing them so that he would vacate his house.

He alleged in the FIR that on Jan 16, Kajal was riding her scooter and when she was about to enter the society, Patni suddenly closed the remote operated gate which hit Kajal and she fell down.

She was admitted to a private hospital near Vijay Crossroads where she was diagnosed with internal injuries.

When Rajesh raised this issue with Kesarimal and Shah, they threatened Rajesh saying that if he brought up the matter with them again, he would be forced to leave his house.

Rajesh said he was scared and busy with his wife's treatment so he did not approach the police earlier.

Shahibaug police registered a complaint of causing hurt, uttering abusive words, criminal intimidation, abetment and wrongful restraint against Patni, Kesarimal and Shah.
