




Box Office: Q3, FY17-18 vs Q3, FY16-17




Box Office: 9M, FY17-18 vs 9M, FY16-17





Net Box Office & Film Hire: Q3, FY17-18 vs Q3, FY16-17




Net Box Office & Film Hire: 9M, FY17-18 vs 9M, FY16-17



F&B: Q3, FY17-18 vs Q3, FY16-17




F&B: 9M, FY17-18 vs 9M, FY16-17




Sponsorship Revenues: Q3, FY17-18 Vs Q3, FY16-17
