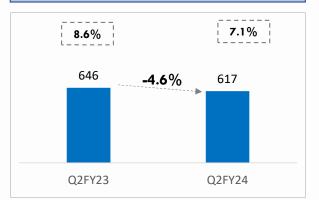




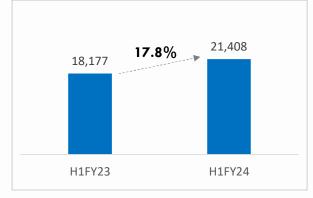


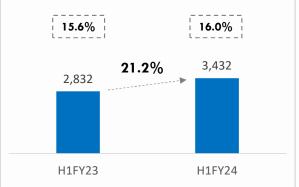


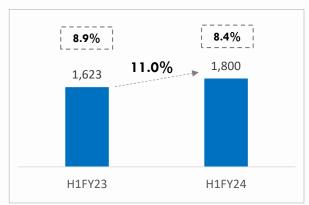
#### PAT & PAT Margin (%)

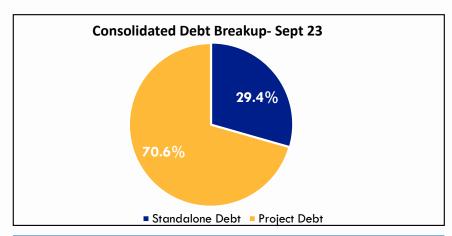


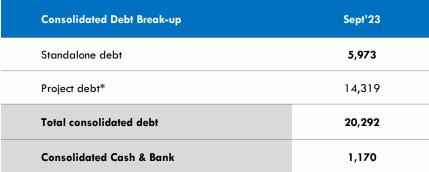

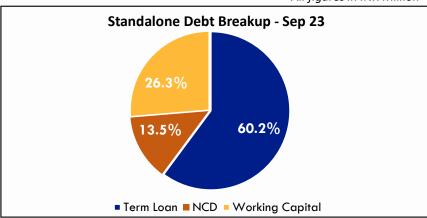
### **Debt Breakup**

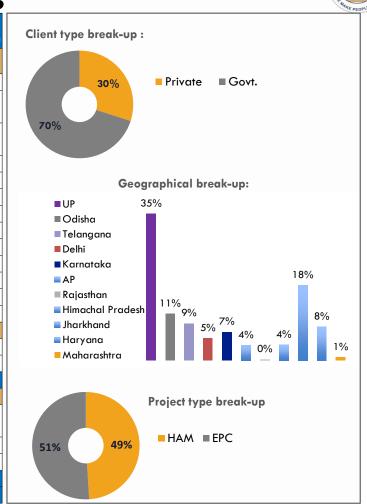
