Sub: Disclosure of continuing event or information under Regulation 30(4) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations')

This is further to our disclosure dated August 14, 2023 ('Disclosure') on the above-mentioned subject.

In the said disclosure, TRF Limited ('Company') had, *inter alia,* disclosed details of service tax litigations, pending appeal before the Customs Excise & Service Appellate Tribunal ('CESTAT'), Kolkata; contesting:

- a. the demand of Service Tax for the purpose of computing Service Tax liability under the Works Contract composition scheme amounting to ₹2,942 lakhs. The litigation/dispute pertains to July, 2007 to May, 2013; and,
- b. the denial of abatement under Notification No.1/2006-ST due to avialment of CENVAT credit on common input services, in relation to construction & erection, commissioning & installation services amounting to ₹830 lakhs. The litigation/dispute pertains to October 1, 2006 to March 31, 2012.

We wish to inform you that, on March 4, 2024, the Company has received Final Orders from the Customs, Excise & Service Tax Appellate Tribunal, Kolkata, ('Tribunal') on both the matters, whereby the Tribunal has set aside the Demand Orders of Commissioner of Central Excise & Service Tax, Patna and Commissioner of Central Excise & Service Tax, Jamshedpur, respectively.
