On Remote E- Voting and Electronic Voting in respect of Resolutions proposed through Postal Ballot [Pursuant to Section 110 of the Companies Act, 2013 and Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014]

To, Mr. Deepesh Shah (Company Secretary & Compliance Officer) Jetking Infotrain Limited

- A. The Board of Directors of M/s. Jetking Infotrain Limited (hereinafter referred to as ("the Company") has appointed Mr. Anand Mukherjee (Membership No. F11804), Partner of M/s. AVS & Associates, Company Secretaries as the Scrutinizer by way of a resolution passed at the Board Meeting of the Company held on Saturday, March 30, 2024 for the purpose of Scrutinizing Postal Ballot conducted pursuant to the provisions of Section 110 of the Companies Act, 2013 read with rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and other applicable provisions, if any, of the Companies Act, 2013 (the "Act") read with General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/21 dated June 23, 2021 read with other relevant circulars, including General Circular No. 20/2021 dated December 08, 2021, 3/ 2022 dated May 05, 2022, 11/2022, dated 08.12.2022 and General Circular No. 09/2023 dated September 25, 2023, issued by Ministry of Corporate Affairs ("MCA") (collectively referred to as ("MCA Circulars") and in compliance with the provisions of the Companies Act, 2013 ("Act") and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") only through the E-voting process in a fair and transparent manner for following resolutions as mentioned in the Notice of Postal Ballot dated 30th March, 2024:

- B.
