Pursuant to Regulation 30 read with Part A (B) of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, this is to inform that Ircon International Limited (the Company) has been awarded the following work of Rs.723 Crores by NCRTC:

- a. Design, Supply, Installation, Testing and Commissioning of Receiving Sub-Stations and associated works on Viaduct & Tunnel from Sarai Kale Khan to Duhai (EPE) [including Jangpura Stabling Yard and Duhai Depot] and SCDA system for Complete Corridor of Delhi- Ghaziabad-Meerut RRTS Corridor of NCRTC for the accepted contract amount of approx. Rs.318 Crores. The tenure for execution of works is 50 months.
- b. Design, Supply, Installation, Testing and Commissioning of Receiving Sub-Stations and associated works on Viaduct & Tunnel from Duhai (EPE) to Modipuram [including Modipuram Depot] for Delhi- Ghaziabad-Meerut RRTS Corridor of NCRTC for the accepted contract amount of approx. Rs.405 Crores. The tenure for execution of works is 54 months.
