


# Financial Performance – Standalone Q1 FY23







# Financial Performance – Consolidated Q1 FY23








# Machined Camshafts vs Camshafts Castings – Q4FY22 vs Q1FY23
















## Performance – Contribution towards Consolidated Income – Q1 FY23
