मुख्यमंत्री अरविंद केजरीवाल ने सोमवार को कहा कि यदि लोकसभा चुनाव के परिणाम की घोषणा के बाद इंडिया गठबंधन सत्ता में आता है तो वह पांच जून को तिहाड़ जेल से बाहर आ जाएंगे। उन्होंने यह बात लोकसभा चुनाव की तैयारियों को लेकर पार्टी के निगम पार्षदों के साथ बैठक के दौरान कही।

केजरीवाल ने आम आदमी पार्टी के पार्षदों को संबोधित करते हुए आरोप लगाया कि तिहाड़ में हिरासत के दौरान उन्हें अपमानित करने के प्रयास किया गया। जेल से वापस आने के बाद पार्षदों से यह उनकी पहली बैठक थी। मुख्यमंत्री ने पार्षदों को और मेहनत व लगन के साथ दिल्ली की साफ-सफाई कार्य में जुटने का आ''ान किया। उन्होंने दावा किया कि तिहाड़ जेल में मेरी कोठरी में दो सीसीटीवी कैमरे थे और 13 अधिकारी उस पर पल-पल

सरोजनी नगर थाना क्षेत्र में रविवार देर रात करीब 03:27 बजे दिल्ली पुलिस के वाहन की चपेट में आने से 58 साल के शख्स की मौके पर ही मौत हो गई। मौके पर पहुंची पुलिस टीम ने घायल को अस्पताल में भर्ती कराया जहां चिकित्सकों ने उन्हें मृत घोषित कर दिया। आरोपी वाहन चालक की पहचान दिल्ली पुलिस के कांस्टेबल प्रदीप कुमार के तौर पर की गई है। शुरुआती जांच में पता चला है कि घटना के वक्त कांस्टेबल काफी तेज रफ्तार में वाहन चला रहा था। आरोपी के खिलाफ मामला दर्ज कर लिया गया है।

दक्षिणी पश्चिमी जिला पुलिस उपायुक्त रोहित मीणा ने सोमवार को बताया कि 58 साल के बैजनाथ उर्फ राकेश गृप्ता अपने परिवार के साथ त्रिलोकपुरी में रहते थे। उनकी बेटी शिवानी गुप्ता मीडिया इंफलुसर हैं। पुलिस ने बताया कि देर रात सुचना मिली थी कि भीकाजी कामा प्लेस मेट्टो स्टेशन के पास दिल्ली पुलिस के एसएचओं लिखा वाहन चला रहे चालक एक शख्स को टक्कर मार दी है। हादसे में शख्स की मौत हो गई है। मौके पर पहुंची पुलिस टीम ने पाया कि शख्स गंभीर रूप से घायल है और वाहन क्षतिग्रस्त अवस्था में खड़ी है।

और हमारे काम के कारण भाजपा डरती है। केजरीवाल ने कहा कि उनकी गिरफ्तारी के बाद आप टूटने के बजाय और अधिक एकजूट हो गई। उन्होंने कहा कि भाजपा ने दिल्ली और एमसीडी की सरकार गिराने के लिए मुझे गिरफ्तार किया. लेकिन नाकाम रही। केजरीवाल ने कहा कि मैं मानसिक तौर पर तैयार था कि मुझे छह महीने जेल में रहना पड़ेगा, लेकिन ऊपर वाले की कृपा से आप सबके बीच में हूं। उन्होंने कहा कि अगले 21 दिनों में जहां-जहां संभव होगा, वहां जाऊंगा और भाजपा को हराने के लिए प्रचार करूंगा।

केजरीवाल ने कहा कि मुझे दो जून को जेल वापस जाना होगा। मैं जेल के अंदर चार जून को चुनाव परिणाम देखूंगा। यदि इंडिया गठबंधन सत्ता में आती है तो पांच जून को मैं वापस आऊंगा। इस दौरान आप के राष्ट्रीय महासचिव (संगठन) संदीप पाठक ने पार्षदों से बूथ स्तर पर मजबूती से जनसंपर्क करने को कहा।

दिल्ली के सदर बाजार इलाके में सोमवार सुबह तेज रफ्तार डंपर ने एक व्यक्ति को कुचल दिया, जिससे उनकी मौत मौके पर ही हो गई। मृतक के परिवार वालों ने डंपर के आगे बैठकर विरोध करना शुरू किया तो एक पुलिसकर्मी ने उन्हें हटाने के लिए डंडे चलाए। डंडे चलाने के बाद इलाके के लोगों ने खूब बवाल काटा। पुलिस इस मामले में सोमवार रात तक चुप्पी साधे हुए रही पुलिस के मुताबिक 36 साल के राहुल को दिल्ली मैट्रो के निर्माण में लगे डंपर ने टक्कर मारी थी, वह पास की झुग्गी बस्ती में परिवार के साथ रहते थे।

राष्ट्रीय महिला आयोग (एनसीडब्लू) राज्यसभा सदस्य स्वाति मालीवाल पर कथित हमले की जांच के लिए एक टीम भेजेगा। एनसीडब्लू ने कहा कि वह इस मामले में कार्रवाई रपट (एटीआर) भेजने के लिए दिल्ली पलिस को एक औपचारिक पत्र भी भेजेगा। आयोग ने 'एक्स' पर एक पोस्ट में कहा कि राज्यसभा सदस्य स्वाति मालीवाल के साथ दिल्ली के मुख्यमंत्री के आवास पर कथित तौर पर मारपीट की गई।

आयोग ने कदम उठाते हुए दिल्ली पुलिस से न्याय की मांग की है और एक जांच टीम भेजी है। पोस्ट में कहा गया कि अपराधियों को जवाबदेह ठहराया जाना चाहिए। आयोग इस मामले में तीन दिन में एटीआर भेजने के लिए दिल्ली पुलिस को एक औपचारिक पत्र भेजेगा। दिल्ली महिला आयोग की पूर्व अध्यक्ष और आप की राज्यसभा सदस्य मालीवाल ने सोमवार को मुख्यमंत्री के निजी कर्मी पर दुर्व्यवहार करने का आरोप लगाया। पुलिस को अब तक इस मामले में कोई औपचारिक शिकायत नहीं मिली है।

दिल्ली भाजपा महामंत्री कमलजीत सहरावत एवं मंत्री बांसरी स्वराज ने प्रदेश कार्यालय में संयुक्त प्रेसवार्ता कर स्वाति मालीवाल के साथ किए गए दुर्व्यवहार की कड़ी निंदा की। उन्होंने कहा कि जब आम आदमी पार्टी की सांसद एवं दिल्ली महिला आयोग की पूर्व अध्यक्ष मुख्यमंत्री आवास में सुरक्षित नहीं है तो फिर दिल्ली की महिलाएं कैसे सुरक्षित हो सकती है। कमलजीत सहरावत ने कहा कि जो मुख्यमंत्री दिल्ली की महिलाओं की सुरक्षा की बात करते थे, आज 'जो गारंटियां बांट रहें, उनके घर में ही महिला सुरक्षा की गारंटी नहीं'

भाजपा नेता अरविंदर सिंह लवली ने कहा कि स्वाति मालीवाल के साथ मुख्यमंत्री आवास के अंदर हुई घटना काफी शर्मनाक है। उन्होंने कहा कि यह इंडिया गठबंधन किस प्रकार का गठबंधन है जिसमें एक पार्टी के अंदर इतनी बड़ी घटना हो गई और अभी तक किसी भी कांग्रेस नेता की प्रतिक्रिया नहीं आई। लवली ने कहा कि जो लोग पूरे देश में गारंटियां बांट रहे हैं आज उनके घर में ही महिला सुरक्षा की गारंटी नहीं है। वहीं इस मामले में प्रदेश भाजपा अध्यक्ष वीरेंद्र सचदेवा ने कहा है की अरविंद केजरीवाल का अपनी एनजीओ समय की साथी स्वाति मालीवाल से दुर्व्यवहार कोई पहला मामला नहीं है। उन्होंने कहा कि एनजीओ युग की उनकी साथी किरण बेदी, शाजिया इल्मी, ऋवा पांडेय जैसे कितनी महिला अरविंद केजरीवाल की महिला विरोधी राजनीति से तंग आकर उनका साथ छोड़ चुकी हैं। सचदेवा ने कहा कि जानकारी के अनुसार स्वाति मालीवाल ने अरविंद केजरीवाल से कुछ तीखे सवाल किए थे जिसका जवाब देने की जगह केजरीवाल के सहयोगी ने दुर्व्यवहार किया। उन्होंने मांग की कि इस पूरी घटना की जांच की जाए और सच को सामने लाया जाए।

उनके घर के अंदर ही महिला के साथ दुर्व्यवहार हो रहा है। उन्होंने दिल्ली पुलिस से गुजारिश है कि इस घटना की जांच जल्द कर इसका खुलासा करें। बांसूरी स्वराज ने कहा कि एक महिला पर हाथ उठाना और उनके साथ दुर्व्यवहार शर्मसार करने की बात है।

आधिकारिक कार्यालय में इस तरह की घटना का होना बेहद ही दुखद है। उन्होंने इस घटना को लेकर केजरीवाल से स्पष्टीकरण देने की मांग की हैं। कहा कि इससे पहले भी मुख्य सचिव के साथ मारपीट की घटना सामने आ
