## Sub: Grant of Stock Options under Employees Stock Option Scheme – 2020

Pursuant to provisions of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other applicable circulars, we wish to inform you that in terms of the approval granted by the Shareholders of the Company at the Annual General Meeting held on July 23, 2020, the Nomination & Remuneration Committee (NRC) of the Board of Directors of the Company at its meeting held today i.e. on February 22, 2021 has approved the scheme document of Employees Stock Option Scheme – 2020 (ESOS – 2020), formulated in terms of SEBI (Share Based Employees Benefits) Regulations, 2014 and also approved the grant of 11,45,000 stock options representing 11,45,000 equity shares of Rs. 5/- each to the eligible employees of the Company as determined by the NRC, under ESOS – 2020 at grant price of Rs. 2,934.25 per option.

## Details of grant of stock options are provided below:

a.	Brief details of options granted	11,45,000 stock options granted to eligible employees of the Company as determined by the NRC.  Each option upon exercise would be entitled for allotment of one equity share of Rs. 5/- each of the Company.

d.	Pricing Formula	The said stock options have been granted at the market price as defined in SEBI (Share Based Employees Benefits) Regulations, 2014.  Accordingly, the stock options have been granted at Rs. 2,934.25 per option, being the latest available closing price of the shares of the Company on National Stock Exchange of India Limited, on February 19, 2021 being the previous trading day immediately preceding the date on which Grant of Options was approved by the NRC.
e.	Options vested	Subject to the fulfilment of the conditions as specified in ESOS – 2020, the options shall vest in three tranches.  1st tranche - 1/3rd of the options granted shall vest on the completion of 1 (one) year from the date of grant;  2nd tranche - 1/3rd of the options granted shall vest on the completion of 2 (two) years from the date of grant;  3rd tranche - balance 1/3rd of the options shall vest on the completion of 3 (three) years from the date of grant.
f.	Time within which options may be exercised	All the vested options will have to be exercised by the eligible employees within 5 (five) years from the date of respective vesting.
