**Sub.: Intimation regarding acquisition of 49% stake in Sirius Digitech Limited by Adani Global Limited, Mauritius (a Wholly Owned Subsidiary of the Company)**

**Ref.: Disclosure pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.**

With reference to the captioned subject, we would like to inform that Adani Global Limited, Mauritius ("Adani Global"), a wholly owned subsidiary of the Company ("WOS"), has executed a Share Purchase and Shareholders' Agreement pursuant to which Adani Global has acquired 49% stake in a UAE based entity named Sirius Digitech Limited ("Sirius Digitech") from Sirius International Holding Limited ("Sirius Holding") on May 9, 2024 (confirmation of the same is received by the Company on May 9, 2024 at 3:40 p.m. IST). Further, the Shareholders Agreement contemplates that as a part of proposed transaction, the Company would also divest its entire stake in two of its Indian subsidiaries, in favour of Sirius Digitech at fair market value, calculated by an independent valuer, and a separate disclosure in this regard shall be submitted to the stock exchanges, as and when such divestment is consummated.
