I have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by RELIANCE POWER LIMITED (hereinafter referred as 'the listed entity'), having its Registered office at Reliance Centre, Ground Floor, 19, Walchand Hirachand Marg, Ballard Estate, Mumbai - 400001.
