Dear Sir,

I, Smita Sharma, (ACS-17757 / CP-6077) of M/S Smita Sharma & Associates, Company Secretaries in whole time Practise, Kolkata was appointed as the scrutinizer by the Board of Directors for the remote e-voting as well as the e-voting by Members during the 63<sup>rd</sup> Annual General Meeting ("AGM") of **Gokul Solutions Limited** (hereinafter referred to as "**the Company**") scheduled on Thursday, 28th December, 2023 at 12:00 Noon held in physical mode. Our responsibility as a Scrutinizer was to ensure that the voting process was conducted in a fair and transparent manner and submit a Scrutinizer's report on the voting on the 1 (One) resolutions based on the reports generated from the electronic voting system.

I submit the report as under:

1. The Company held the 15<sup>th</sup> AGM on 28th December, 2023 in physical mode at 12:00 Noon IST in accordance with the provisions of Companies Act, 2013 (the Act) read with the Ministry's General Circular No. 20/2020, dated 05th May, 2020, General Circular No. 02/2021, dated 13.01.2021, General Circular No. 19/2021, dated 08.12.2021, 21/2021 dated 14.12.2021, General Circular No. 02/2022, dated 05.05.2022 and General Circular No. 10/2022 dated 28.12.2022, it has been decided to allow companies whose AGMs is due to be held in the year 2023, to conduct their AGMs on or before 30.09.2023, in accordance with the requirements provided in paragraphs 3 and 4 of the General Circular No. 20/2020 dated 05.05.2020.
2. The compliance with the provisions of the Companies Act, 2013 and the Rules made there under relating to voting at the AGM by the shareholders on the resolutions set out in the Notice of the 15<sup>th</sup> Annual General Meeting of the Company is the responsibility of the management.  
  
My responsibility as a Scrutinizer was to ensure that the e-voting process is conducted in a fair and transparent manner and render Scrutinizer's Report of the total votes cast in favour or against if any, to the Chairman on the resolutions.
3. The Company has informed that on the basis of Register of members, it has completed dispatch of Notice of AGM and Annual Report by E-mail (who had registered their email ids).
4. Voting rights were reckoned as on Thursday, December 21, 2023 being the Cut-off date for the purpose of deciding the entitlements of members at the remote E-voting.
5. The Company has availed the services of Central Depository Services (India) Limited ("CDSL") to provide e-voting facilities to the members of the Company.
6. Remote e-voting platform was open from 9.00 a.m. on Monday, December 25, 2023 till 5.00 p.m. on Wednesday, December 27, 2023 and members were required to cast their votes electronically conveying their assent or dissent in respect of the Resolutions on the remote e-voting platform provided by CDSL.



7. For the purpose of ensuring that Shareholders who have cast their votes through remote e-voting do not vote again at the General Meeting, the Scrutinizer shall have access after closure of period of remote e-voting and before the start of General Meeting, to only such details relating to Shareholders who have cast their votes through remote e-voting, such as their names, DP ID & Client ID/ folios, number of shares held but not the manner in which they have voted.
8. Accordingly, CDSL, the remote e-voting agency provided us with names, DP ID & Client ID/folios and shareholding of members who had cast their votes through remote e-voting.
9. The Company through CDSL provided e-voting facility to members attending the AGM who had not cast their votes through remote e- voting to cast their votes.
10. On completion of voting at the AGM, CDSL provided us with the list of members who had cast their votes, their holding details and details of votes cast on the Resolution.
11. Votes were reconciled with the records maintained by the Company and Share transfer Agent of the Company (RTA) with respect to authorizations lodged with the Company.
12. We unblocked the remote e-voting results on the CDSL remote e-voting platform and downloaded the remote e-voting results.
13. **RESULTS (EVSN: 231202001)**

We observed that:

1. No members had cast their votes through remote e-voting
2. 11 members had cast their votes at the AGM.
