This communication is in continuation to our earlier disclosure dated November 14, 2023 with respect to acquisition by way of additional equity infusion up to Rs. 255 Lakhs in the equity capital of Isgec Titan Metal Fabricators Private Limited, joint venture and subsidiary of the Company, by March 31, 2024.
- 2. Due to some procedural delays, some additional time-period is required to complete the transaction by Isgec Titan Metal Fabricators Private Limited. It is now expected to complete the transaction by September 30, 2024 in place of earlier disclosed indicative time-period.
- 3. There is no other change in the transaction and disclosure filed earlier except revision in expected timeperiod for completion of the transaction.
