In continuation of our earlier disclosure filed under Regulation 7(2) of SEBI (Prohibition of Insider Trading) Regulations, 2015, 2,90,00,000 (9.55%) equity shares which are under Lock-in, held in the name of April Investment and Finance Private Limited, stand transferred with lock-in to Hertz Electricals (International) Private Limited (Hertz) and are deemed to have been directly acquired by Hertz. Since, April Investment and Finance Private Limited have amalgamated in Hertz Electricals (International) Private Limited and stand dissolved, shares held by them in Paramount Communications Limited are now held by Hertz Electricals (International) Private Limited, the Amalgamated Company and there is no change in the shareholding of the Promoter and Promoter Group of Paramount Communications Limited. Accordingly, the above disclosure shall also be considered as on behalf of the erstwhile company, namely, April Investment and Finance Private Limited for transfer of shares held by them.

Further, April Investment and Finance Private Limited, Amalgamated Company, holds 4,20,40,172 shares in Paramount Communications Limited (Target Company). Out of which 1,27,84,712 shares are pledged with M/S Invent Assets Securitisation & Reconstruction Private Limited. Hence, 1,27,84,712 shares will be transferred on receipt of approval from pledgee and forms part of the above-mentioned transfer transaction.
