**Post-Buyback Public Announcement pursuant to Regulation 24(vi) of the Securities and Exchange Board of India (Buy Back of Securities) Regulations, 2018 in relation to the buyback of equity shares of Rs. 10 each of Arnold Holdings Limited ("Company") for an aggregate consideration not exceeding Rs. 13,23,00,000 (Rupees thirteen crores twenty three lakhs only) excluding the transaction cost ("Buyback Offer")**

The Buyback Offer of the Company opened on Thursday, February 1, 2024 and closed on Wednesday, February 7, 2024.
