- The Company has incorporated a subsidiary named "PSL Recycling Private Limited" in the Previous Quarters, i.e. Quarter ended 30th June 2019. The same was also informed to the Bombay Stock Exchange through its communication dated 29th May 2019. We would like to state that as on 30th September,2020 there have been no transactions with the said subsidiary other than the payment of share capital. Since there have been no transactions and since the same is not material, the Company has not submitted Consolidated Results for the Quarter ended 30th September 2020.
- The Company had commenced Activities of Waste Paper and Allied Products in the preceding financial year and therefore the Company has a reportable segment i.e Infrastructure and Real Estate and Waste Paper & Allied products. In accordance with Indian Accounting Standards (Ind-AS 108), the Company has disclosed Segment results in the Financial Results.
