Complaint	Referred with 3 weeks history of painful lump in right breast. No previous breast problems or screening mammography done
Observation	RISK FACTORS FOR BREAST CANCER: There is no family history of breast cancer. Age of menarche - 14 years. Age of surgical menopause - 52 years. No of children - 3: Age- 51,45 &40 years; Breast fed for 8 months
	PAST MEDICAL HISTORY: 1) Hypertension- 12 years 2) Paraumbilical Hernia- Awaiting surgery 3) Osteoarthritis Right Knee- 2006 4) Hysterectomy 5) Cholecystectomy
	DRUG HISTORY: T.Telma AM 1-0-0. No history of drug allergies.
	CLINICAL EXAMINATION: Breast examination showed 3.5cm palpable lump in right breast 2 oclock 3cm from the nipple suggestive of Malignant lump (P6).Left breast felt completely normal with no discrete lumps to feel (P1). There was no palpable axillary or supraclavicular lymphadenopathy.
Investigations	MAMMOGRAM: Biltateral mammogram showed scattered fibroglandular breast tissue (Type 1 Tabar pattern) with 3cm irregular spiculated mass lesion in the upper inner aspect of the right breast involving Pectoralis major muscle suggestive of Malignant lesion (BIRADS M5).
	ULTRASOUND BREASTS: Bilateral breast ultrasound scan showed a 31.7mm × 23.2mm hypoechoic homongenous lesion in the right breast 2 o'clock position 3cm from the nipple suggestive of Malignant Lump(U6).Right axillary ultrasound showed 24.4 x 16.1mm oval lesion suggestive of Involved node .Left breast ultrasound showed no significant abnormality.Left Axillary ultrasound showed 24.4 x 10mm hypoechoic oval lesion suggestive of Enlarged Axillary node
•	 PROCEDURE: After informed consent, she has had ultrasound guided core biopsies from the right breast lump under local anaesthetic
	 HISTOPATHOLOGY: Core biopsies from left breast lump have confirmed Grade 2 Invasive ductal carcinoma (B5) .ER, PR and Her2 has been requested on the core biopsy sample
	• STAGING INVESTIGATIONS: A Staging PET CT showed Irregular hypermetebolic mass in upper inner quadrant of right breast with Infiltration of Pectoralis major muscle with Level 1 Right Axillary and Right Internal Mammary nodes suggestive of Lymphnode metastasis. Enlarged and Hypermetebolic left axillary ,left supraclavicular, paratracheal and left hilar lymphnodes -?Granulomatous/? Distant lymphnode Metastasis to lung, liver or bone.
	 LEFT AXILLARY NODE CORE BIOPSY: She underwent ultrasound guided left axillary node biopsy which confirmed Granulomatous lymphadenitis. (B2).

 Right breast Grade 2 Invasive ductal carcinoma with involved right axillary & Internal mammary node. Left axillary Granulomatous lymphadenitis.

Notes

 PLAN: She has been counselled regarding the diagnosis and staging and been advised to undergo Neoadjuvant chemotherapy with 4 cycles followed by surgery (Right mastectomy and axillary clearance). ER, PR and Her2 results are awaited and she needs to be referred to the medical oncologist urgently. Routine blood tests, ECG Echocardiogram, Chest Xray requested. Commenced on AKT4 and T.Benadone 40mg od for 2 months followed by AKT2 for 4 months for Granulomatous lymphadenitis.
