

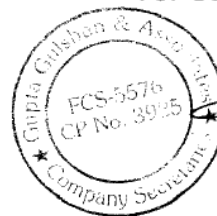
**CERTIFICATE UNDER REGULATION 40 (9) OF THE SEBI (LODR) REGULATIONS

The Securities and Exchange Board of India vide notification dated 8th June 2018 read with press release dated 3rd December, 2018 has amended Regulation 40 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and has mandated that the transfer of securities shall be only in dematerialized form w.e.f. 1st April, 2019.
