The Nomination and Remuneration Committee ("NRC") of the Company has approved further grant of 1,11,226 Restricted Stock Units ("RSUs") exercisable into 1,11,226 equity shares of the Company of face value of Re. 1 each fully paid-up to selected employees of the Company as determined by the NRC, in terms of the RSU Plan 2022. The grant date is 1st March, 2024.

The requisite disclosure as per Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated 9th September, 2015 is as under:

The Board of Directors and Shareholders of the Company had approved the RSU Plan 2022 on 14th September, 2022 and 25th October, 2022, respectively. The NRC of the Company had approved grant of 11,92,792 (Grant Date - 1st January, 2023) and 24,786 (Grant Date - 1st June, 2023) Restricted Stock Units.

The Shareholders of the Company had approved bonus issue of 1:2 on 15th June, 2023 and in terms of the RSU Plan 2022, necessary adjustments had been made to the RSUs already granted to the employees. Additional grant of 5,75,198 RSUs (1st Lot) and 12,392 RSUs (2nd Lot) to the employees still on rolls of the Company had been made, towards adjustment of grants on account of the bonus issue.

The NRC of the Company has approved further grant of 1,11,226 Restricted Stock Units exercisable into 1,11,226 equity shares of the Company of face value of Re. 1 each fully paid-up to selected employees of the Company as determined by the NRC, in terms of the RSU Plan 2022.
