

फाइजर का कोरोना टीका 95 प्रतिशत तक कारगर

न्यूयॉर्क, आईएनएस। फाइजर और उसके जर्मन पार्टनर बायोएन्टेक ने बुधवार को अंतरिम परिणामों का एक दूसरा बैच जारी किया, जिसमें कहा गया है कि उसका कोरोनावायरस का टीका 95 प्रतिशत तक कारगर है। यह बुजुर्ग लोगों को वायरस का शिकार होने के जोखिम से भी बचाता है। कंपनी ने कहा, 'प्राथमिक विश्लेषण से पता चलता है कि वैक्सीन की पहली खुराक के 28 दिनों के अंदर यह अपना प्रभाव दिखाने लगता है। ट्रायल के दौरान कोविड-19 के 170 पुष्ट मामलों का मूल्यांकन किया गया।' ये घोषणा 9 नवंबर को फाइजर की पहली धमाकेदार घोषणा के एक हफ्ते बाद आई है, जब इसमें कहा था कि इसका टीका 90 प्रतिशत तक प्रभावी है। पहला परिणाम 43,000 से अधिक स्वयंसेवकों में से चुने गए 100 से कम संक्रमित मरीजों के विश्लेषण पर आधारित था।

अमेरिका में अब लोग स्वयं कर सकेंगे कोरोना की जांच

वाशिंगटन, वार्ता। अमेरिका के खाद्य एवं औषधि प्रशासन विभाग (एफडीए) ने कोरोना वायरस (कोविड-19) की जांच के लिए ऐसी पहली किट को मंजूरी प्रदान की है जिसका इस्तेमाल आम लोग अपने घर पर ही कर सकते हैं और इसके संक्रमण का पता लगा सकते हैं। एफडीए ने एक बयान में कहा, 'अमेरिकी खाद्य एवं औषधि प्रशासन विभाग ने कोविड-19 की जांच के लिए ऐसी पहली किट को मंजूरी प्रदान की है जिसका इस्तेमाल आम लोग अपने घर पर ही कर सकते हैं और इसके संक्रमण का पता लगा सकते हैं। इसका इस्तेमाल केवल आपात स्थिति में ही किया जा सकता है। इस किट का नाम लूसिआ कोविड-19 ऑल इन वन जांच किट है। इसके जरिये कोविड-19 महामारी पैदा करने वाले सास कोव-2 वायरस की पहचान की जाती है।' इस किट के जरिये नाक के स्वेब का नमूना लेकर करीब 30 मिनट के भीतर यह पता लगाया जा सकता है कि व्यक्ति कोरोना से संक्रमित है अथवा नहीं। इस किट का इस्तेमाल केवल 14 अथवा उससे अधिक उम्र के लोग ही कर सकते हैं।

रूस के साथ संबंधों की घनिष्ठता के लिए तैयार जापान

मास्को, स्पूतनिक। रूस में जापान के राजदूत तोयोहिसा कोजुकी ने कहा है कि रूस के राष्ट्रपति व्लादिमीर पुतिन और जापान के नए प्रधानमंत्री योशीदा मुने ने बातचीत की अच्छी शुरुआत की है और जापान हर क्षेत्र में रूस के साथ संबंधों को मजबूत बनाने के लिए तैयार है।

श्री पुतिन ने 29 सितंबर को जापान के नए प्रधानमंत्री से पहली बार फोन पर बातचीत की थी। दोनों नेताओं ने बातचीत के दौरान सामान्य रूप से दोनों देशों के बीच और एशिया-प्रशांत क्षेत्र के हित में द्विपक्षीय सहयोग के सभी पहलुओं के निरंतर विकास के लिए प्रतिबद्धता को सुनिश्चित भी किया था।

ब्रसेल्स, वार्ता। यूरोपीय संसद (एमईपी) के फ्रांसीसी सदस्य जॉर्डन बर्डेलो ने तुर्की, पाकिस्तान, कुवैत और कतर के खिलाफ कई प्रतिबंध लगाने की मांग की है। हाल के दिनों में एक के बाद एक कई आतंकवादी हमलों का निशाना बन चुके फ्रांस के बर्डेलो का मानना था कि 'यूरोपीय एकजुटता को मूर्तरूप' देने के लिए इस तरह के प्रतिबंध आवश्यक हैं। उन्होंने कहा कि जैसा कि इन देशों को आतंकवाद का समर्थन करने के लिए माना जाता है इसलिए उनके खिलाफ 'वास्तविक वित्तीय या व्यापार प्रतिबंध' लगाया जाना चाहिए।

कोरोना वायरस (कोविड-19) के तेजी से बढ़ रहे मामलों के बीच विश्व में इससे संक्रमितों की संख्या साढ़े पांच करोड़ के पार पहुंच गयी है और इस महामारी से अबतक 13.38 लाख से अधिक लोगों की मौत हो चुकी है। पूरे विश्व में दर्ज किये गए कोरोना के कुल मामलों में से लगभग 48 प्रतिशत मामले अमेरिका, भारत और ब्राजील के हैं। इस महामारी से संक्रमित लोगों और मृतकों की संख्या के मामले में पहले, दूसरे और तीसरे स्थान पर क्रमशः अमेरिका, भारत और ब्राजील है। इस संक्रमण से तेजी से मुक्त होने वाले लोगों की संख्या के मामलों में भारत, ब्राजील और अमेरिका क्रमशः पहले, दूसरे और तीसरे स्थान पर हैं।

अमेरिका की जॉन हॉपकिन्स यूनिवर्सिटी के विज्ञान एवं



ईजीनियरिंग केन्द्र (सीएसएसई) की ओर से जारी आंकड़ों के अनुसार विश्व के 190 देशों में कोरोना वायरस से अब तक 55,624,484 लोग संक्रमित हुए हैं और 13,38,100 लोगों की मौत हुई है। कोरोना से सबसे अधिक प्रभावित अमेरिका इस महामारी से संक्रमितों और मृतकों के मामले में यह पहले स्थान पर है और संक्रमण से मुक्त होने वाले लोगों के मामले में यह तीसरे स्थान पर है। अमेरिका में अब तक 11,357,244 लोग संक्रमित हुए

दक्षिण ऑस्ट्रेलिया में छह दिनों का लॉकडाउन

कैनबेरा ■ स्पूतनिक ऑस्ट्रेलिया के दक्षिणी क्षेत्र में वैश्विक महामारी कोरोना वायरस से संक्रमित मरीजों से संपर्क में आये लोगों का पता लगाने के लिए अधिकारियों ने छह दिनों का लॉकडाउन लगाने की घोषणा की है ताकि कोरोना वायरस को क्षेत्र में फैलने से रोका जा सके। दक्षिण ऑस्ट्रेलियाई प्रीमियर स्टीवन मार्शल ने बुधवार को यह जानकारी दी। उन्होंने संवाददाता सम्मेलन के दौरान कहा, बुधवार रात से हमने इलाके में छह दिन का लॉकडाउन लगाने का निर्णय किया है। इस दौरान अलग-अलग तरीके के प्रतिबंध लगाए जायेंगे जिससे लोगों का बाहर आना-जाना कम हो सके और वायरस के प्रसार को रोका जा सके।

उन्होंने कहा कि छह दिन के लॉकडाउन के दौरान स्कूल,खाद्य

सेवाएं खाने के आर्डर, मनोरंजन के स्थल और निर्माण स्थल बंद रहेंगे। साथ ही, बाहरी खेल गतिविधियां, शादी समारोह और अंतिम संस्कार समारोह पर भी प्रतिबंध रहेगा तथा घर के बाहर हर जगह मास्क अनिवार्य होगा। इसके अलावा हर घर से केवल एक व्यक्ति को प्रति दिन किराने की खुरीदारी के लिए बाहर जाने की अनुमति होगी।

उन्होंने छह दिनों के लिए लॉकडाउन लगाने का कारण बताते हुए कहा, वर्तमान में दक्षिण ऑस्ट्रेलिया में हमने चौथी जेनेरेशन तक कोरोना मरीजों से संपर्क में आये लोगों का पता लगाने का काम पूरा कर लिया गया है लेकिन पांचवीं जेनेरेशन के लोगों का अभी तक पता नहीं लग सका है। ऑस्ट्रेलिया में कोरोना से अबतक 27,756 लोग संक्रमित हो चुके हैं।

क्रेब्स के बयान से नाराज है ट्रम्प

वाशिंगटन स्पूतनिक। अमेरिका के राष्ट्रपति डॉनाल्ड ट्रम्प साइबर सुरक्षा एवं अवसरचन्ना सुरक्षा एजेंसी (सीसा) के निदेशक क्रिस क्रेब्स से नाराज हैं। श्री ट्रम्प ने कहा है कि वह श्री क्रेब्स से इस साल हुए राष्ट्रपति चुनाव को लेकर दिये गये बयान से नाराज हैं, जिसमें उन्होंने चुनाव में धांधली के आरोप को खारिज कर दिया था। उन्होंने क्रेब्स के बयान के अत्यधिक गलत करार दिया है। उन्होंने कहा, 2020 के चुनाव की सुरक्षा को लेकर दिया गया श्री क्रिस क्रेब्स का हालिया बयान बेहद गलत है। चुनाव के दौरान मृत लोगों द्वारा मतदान करना, पोल वॉचर्स को मतदान स्थलों में जाना की अनुमति नहीं देना, वोटिंग मशीनों में 'गड़बड़ी' जिसके जरिये ट्रम्प टू बिडेन के रूप में वोटों को बदला गया, लैट वोटिंग और कई धांधली की गयी थी।

भारत यूएनएससी सीट के लायक नहीं

लक्ष्मी विलास बैंक के प्रशासक टी एन मनोहरन ने बुधवार को कहा कि बैंक के जमाकर्ताओं का पैसा पूरी तरह से सुरक्षित है। उन्होंने भरोसा



जताया कि नियामक द्वारा तय समयसीमा के अंदर ही बैंक का विलय डीबीएस बैंक इंडिया के साथ हो जाएगा। भारतीय रिजर्व बैंक (आरबीआई) ने मंगलवार को केनरा बैंक के पूर्व गैर-कार्यकारी चेयरमैन टी एन मनोहरन को लक्ष्मी विलास बैंक का प्रशासक नियुक्त किया। आरबीआई ने संकट में फंसे निजी क्षेत्र के बैंक के निदेशक मंडल को हटाने के बाद प्रशासक की नियुक्ति की।

बैंक पर खाने-दने को लेकर पाबंदी लगायी गयी है और प्रति खाता 25,000 रुपये की निकासी की सीमा तय की गयी है।

मनोहरन ने संवाददाताओं से बातचीत में कहा कि उन्हें भरोसा है कि लक्ष्मी विलास बैंक का डीबीएस बैंक इंडिया के साथ विलय 16 दिसंबर, 2020 से पहले हो जाएगा।

प्रशासक ने कहा, 'उनकी पहली प्राथमिकता जमाकर्ताओं को आश्वस्त करना है कि उनका पैसा पूरी तरह से सुरक्षित है और बैंक के पास जमाकर्ताओं का पैसा लोटाने को लेकर पर्याप्त नकदी है।' लक्ष्मी विलास बैंक के पास 20,000 करोड़ रुपये जमा है जबकि उसने 17,000 करोड़ रुपये कर्ज दे रखा है। आरबीआई विलय को लेकर अंतिम मसौदा 20 नवंबर को जारी करेगा।

सोना-चांदी लुटका

मुंबई, वार्ता। अंतरराष्ट्रीय बाजार में दोनों कीमती धातुओं के दाम में रही घटबढ़ के बीच बुधवार को घरेलू बाजार में भी सोने-चांदी के दाम फिसल गये। अंतरराष्ट्रीय बाजार में सोना हाजिर 1,877.65 डॉलर प्रति औंस पर अपरिवर्तित रहा। इस दौरान अमेरिकी सोना वायदा 0.51 प्रतिशत फिसलकर 1,876.60 डॉलर प्रति औंस पर रहा। इस बीच चांदी 0.20 प्रतिशत चमककर 24.51 डॉलर प्रति औंस पर पहुंच गयी। घरेलू स्तर पर वायदा बाजार एमसीएक्स में सोना 1.31 प्रतिशत यानी 663 रुपये की गिरावट में 50,105 रुपये प्रति दस ग्राम पर आ गया। सोना मिनी 1.24 प्रतिशत यानी 624 रुपये लुटकाई 50,185 रुपये प्रति दस ग्राम बोला गया। इस बीच चांदी 1.66 प्रतिशत यानी 1,045 रुपये की गिरावट में 62,197 रुपये प्रति किलोग्राम और

चांदी मिनी 1.64 प्रतिशत यानी 1,041 रुपये की गिरावट के साथ 62,220 रुपये प्रति किलोग्राम बोली गयी।
