Lunglei dist draft electoral roll published

AIZAWL, NOV 16 /--/ Special Summary Revision of Electoral Rolls, 2020 with qualifying date as January 1, 2021 started at Lunglei District today with the publication of Draft Electoral Roll at the DC Conference Hall by Lunglei DC & DEO V. Lalsangliana. The program was attended by Government officials, representatives of political parties, and members of the media. Stating that exercising of the franchise is one of the most important rights and duties of any citizen, the DC&DEO urged those eligible to enroll themselves during the Special Summary Revision exercise. He also urged those present to be proactive in motivating and educating those eligible to come forward to enroll themselves in the Electoral Roll. As per the Draft Electoral Roll for Lunglei District, women voters outnumber men by 457, with only two of the six Assembly Constituencies - Thorang and West Tuipul, both located in the western belt of the District, having more male voters than females. The summary revision will go on till December 15 and the final electoral rolls will be published on January 20, 2021 (Wednesday). Special Campaigns for revision of electoral rolls will also be conducted during the Summary Revision Exercise (generally in polling stations). Forms for inclusion/deletion/modification/transposition of entries in the electoral rolls will be available at these locations. Filled in forms can be submitted there. (DIPR)

Draft E-Roll published in Siaha



AIZAWL, NOV 16 /--/ Kesanvan R, District Election Officer, Siaha district published Draft Electoral Roll for 39-Siaha A/C and 40-Palak A/C, which were prepared by taking January 1, 2021 as qualifying date, and handed over a copy each of Hard and Soft Copy to representatives of all the political parties, here in Siaha, today. In his Draft E/Roll speech; Kesanvan expressed his happiness over the successful publication of Draft E/Roll and profusely thanked all those who involved in the preparation of Draft E/Roll as well. He also firmly stated that "the first step towards a free, fair and inclusive Election originated from a pure and fair E/Roll, and Draft E/Roll is the first exhaustive undertakings in that direction," he quipped. A total of 21962 voters are there in 39-Siaha A/C, and of these voters, 10532 are male voters and 11430 are female voters.

Whereas under 40-Palak A/C, there are 18666 voters, consisting of 9275 male voters and 9391 female voters. DEO Lawngtlai publishes Draft Electoral Roll 2021

AIZAWL, NOV 16 /--/ District Election Officer (DEO), Lawngtlai Dr Andrew H. Vanlalidika published a draft electoral roll 2021 of three assembly constituencies within Lawngtlai District today at DC's Conference Hall and handed over the draft electoral rolls to representatives of the political parties. As per the draft electoral roll, there are 32,403 voters (16,379 males and 16,024 females) in 36-Tuichawng (ST) Assembly Constituency (A/C), 27,038 voters (13,612 males and 13,426 females) in 37-Lawngtlai West (ST) A/C, and 24,484 voters (11,844 males and 12,640 females) in 38-Lawngtlai East (ST) A/C. In total, there are 83,925 voters (41,835 males and 42,090 females) in Lawngtlai District. Claims and objections regarding the draft roll can be filed up to December 15, 2020. The qualifying date for the roll is January 1, 2021. The final electoral roll is scheduled to be published on January 20, 2020. (DIPR)



Kolasib dist draft electoral roll published with 59,822 voters



AIZAWL, NOV 16 /--/ The draft electoral roll for Kolasib district with January 1, 2021 as the qualifying date was published by Dr.H.Lalthlangliana, Deputy Commissioner today. The Roll had a net decrease of 15 voters compared with the previous electoral roll, having 59,837 voters. The Draft E-roll published today have 59,822 voters comprising 29,082 Male and 30,733 female with a sex ratio of 1057. There are 17,577 voters in 4-Tuirial (ST) Assembly Constituency with a decrease of voters by 80. 22,412 voters in 5-Kolasib (ST) Assembly Constituency and 19,833 voters in 6-Tuirial (ST) Assembly Constituency with an increase of 49 and 16 voters respectively in comparison with the previous E-roll.
