- The Board of Directors in its meeting held, discussed about the applicability of Regulation 3(5) and 3(6) of SEBI (PIT) Regulations, 2015, to the Company, which inter alia required SDD to be maintained by the Companies and pursuant to this, Companies are required to submit the SDD compliance certificate within 21 days of the end of each quarter.
- 2. Further, as per circular Notice No: 20230329-20 dated 29.03.2023, it was observed that the listed entities are advised to take a note that the listed entities to whom the provisions of Regulation 24A of SEBI (LODR) Regulations, 2015 are not applicable, are required to continue to submit SDD Compliance certificate on quarterly basis. Since, our Company was migrated to Main Board of SME Exchange from April 2023, the said regulation is applicable to us and hence we are under the impression that we are not required to continue to submit the SDD Compliance Certificate.
