Allotment of Bonus Shares

Pursuant to receipt of approval of shareholders of the company through postal ballot on 27th March, 2024 and after receipt of in-principle approval from BSE Limited ("BSE") vide letter no. LOD/Bonus/BN-IP/VK/23/2024-25 dated 03rd April, 2024, the Board of Directors of the Company in their meeting held today has made allotment of 95,78,951 fully paid-up Bonus Equity Shares of Re. 10/- each in the ratio 1:1 (One) Equity Share of Re 10/- each for every (One) Equity Share of Re 10/- each held by the shareholders of the Company as on the record date 16th April, 2024, in accordance with SEBI (ICDR) Regulations, 2018 and applicable rules.

Pursuant to above said allotment of Bonus Shares, the issued and paid-up equity share capital of the Company stands increased to Rs. 19,15,79,020 divided into 1,91,57,902 equity shares of face value of Re 10/- each.

The Bonus Shares allotted as stated above shall rank pari-passu in all respect and carry the same rights as the exiting equity shares of the company including dividends and other corporate benefits, if any, declared by the Company after the said allotment.
