Subject : Update on Simplified norms for processing investor's service requests by RTAs and norms forfurnishing PAN, KYC details and Nomination

Securities and Exchange Board of India (SEBI) vide its Circular dated November 17, 2023 has amended para 19.2 of SEBI's Master Circular for Registrars to an Issue and Share Transfer Agents dated May 17, 2023 and deleted the provisions of freezing of folios and referring frozen folios to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and /or Prevention of Money Laundering Act, 2002 for cases where KYC details have not been provided by the shareholders.
