#### Discrepancies:

- Explanation for delay not provided for disclosure made under regulation 30(6) of SEBI (LODR)
   Reg., 2015 after 24 hours of occurrence of the event or information and/or
- Full details not provided as per SEBI Circular dated September 09, 2015 for change in Director/KMP/Auditor/Compliance Officer (Reason/Date/profile/Relationship).

In the matter the company has to clarify as under:

- The Statutory Auditor of the company MGA & ASSOCIATES resigned with effect from 10th / November 2022.
- However the resigning Auditor informed about his resignation to the company vide letter 23<sup>rd</sup>
   December 2022 and declared his intention to resign retrospectively with effect from 10<sup>th</sup>
   November 2022.
- 3. Thus the Company came to know about the resignation of Auditor on 23rd December 2022.
- As per law resignation of the Director/KMP/Auditor becomes effective only when it is intimated to the company by the concerned person.
- 5. The company immediately filed intimation of resignation of Auditor vide letter 23rd December 2022.
- Though the Auditor has resigned retrospectively with effect from 10th November 2022 but failed to inform the company. So there is no delay on the part of company to intimate the BSE about the resignation of Auditor as the company came to know about the same vide Auditor's letter dated 23rd December 2022 only.
- Please note that we have clarified this vide our letter dated 25.07.2023 which is Acknowledge by receipt No. 5905481 dated, 26.07.2023
