SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, please note that 3i Infotech Saudi Arabia LLC, a subsidiary company, has received tax demand from the Zakat, Tax and Customs Authority ('ZATCA') amounting to SAR 8.9 million (approx. Rs. 19.6 crore). This demand is related to long outstanding withholding tax and income tax liabilities pertaining to financial year ended March 31, 2008, March 31, 2009 and March 31, 2010, for which ZATCA has approved 12 equal installments starting from the month of April 2024. We have been informed by 3i Infotech Saudi Arabia LLC, the subsidiary company, on June 2, 2024 that the subsidiary company has not been able to pay two installments for April 2024 and May 2024, due to cash flow issues. Consequently, ZATCA has initiated mandatory collection process and blocked immigration of employees of subsidiary and other government portal services. ZATCA has given time till June 8, 2024 to pay two installments for April 2024 and May 2024. If the payment is made by June 8, 2024, immigration of employees of subsidiary and other government portal services will be unblocked.

The disclosure as required under the SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed herewith as "**Annexure- A**".
