## Sub: Payment of Redemption Proceeds on maturity - Commercial papers

This has reference to the SEBI Circular no. SEBI/HO/DDHS/DDHS/CIR/P/2019/115 dated October 22, 2019, and the intimation dated October 15, 2020, whereby it was informed that the Company had allotted Commercial Paper (CPs) for an amount of INR 250 crore (Rupees Two Hundred Fifty Crore Only).
