Mr. N Visweswara Reddy, Chairman of the Company, took the Chair. As the requisite quorum was present, the Chairman of the meeting called the meeting to order.

The Chairman welcomed the members to the meeting and introduced the fellow Panellists to the Shareholders. The Chairman informed that this Annual General Meeting is being held through video conference in accordance with the circulars issued by the MCA and SEBI under the provisions of the Companies Act, 2013 and the SEBI (LODR) Regulations, 2015.

Mr. Ajay Kumar Dhagat, Chairman of Audit Committee and Nomination & Remuneration Committee and Mr. Sharat Chandra Kolla, Chairman of Stakeholders Relationship Committee were present at the Annual General Meeting.



The Chairman acknowledged the presence of statutory auditor Mr. Amar Sunder representing M/s B S R & Co LLP, secretarial auditor Mr. Jayavant Bhawe representing M/s. J B Bhawe & Co, and Scrutinizer Mr. G P Srinath representing M/s G P Srinath & Associates, Company Secretaries in Practice.

The Chairman informed the members that the requisite statutory books and registers are electronically made available in the virtual platform and were open for inspection by the Members of the company.

Thereafter Chairman addressed the Shareholders and highlighted the economic and industrial scenario, business prospects, and performance of the Company for the financial year 2019-20.

Further he informed that the Company had provided the Members the facility to cast their vote electronically through remote e-voting, on all resolutions set forth in the Notice.
