1) To consider and approve the issuance of Warrants convertible into Equity Shares of the Company on a Preferential Basis.

We report that in accordance with the guidelines prescribed by the Ministry of Corporate Affairs ('MCA') for holding general meetings/ conducting postal ballot process through evoting vide General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021, 3/2022 dated May 5, 2022 and 11/2022 dated December 28, 2022 (collectively the 'MCA Circulars'), the Company has sent Postal Ballot Notice only in electronic form to those members whose e-mail addresses were registered with the Company/ Registrar and Transfer Agent ('RTA') / Depositories.

In compliance with Regulation 44 of the SEBI Listing Regulations and pursuant to the provisions of Section 108 and Section 110 of the Companies Act, 2013 read with the rules made thereunder, the MCA Circulars and Secretarial Standard – 2, the Company provided remote e-voting facility to its members, to enable them to cast their votes electronically instead of submitting the Postal Ballot Form physically. The Company engaged the services of Kfin Technologies Limited ('Kfintech') for the purpose of providing remote e-voting facility to its members.

The remote e-voting commenced on Friday, March 01, 2024 at 9.00 a.m. (IST) and ended on Saturday, March 30, 2024 at 5.00 p.m. (IST). During this period, Members of the Company holding shares in physical or electronic form as on Friday, February 23, 2024 ('Cut-Off Date') were eligible to cast their vote electronically. The remote e-voting module was disabled by Kfin Technologies Limited ('Kfintech') for voting thereafter.

My responsibility as scrutinizer is restricted to ensure conduct of postal ballot through remote e-voting in a fair and transparent manner and to make a Scrutinizer's Report of the votes cast 'in favour' or 'against' the resolution stated in the Notice.
