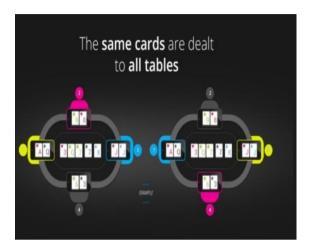
Match Poker is a team sport incorporating regular Texas Hold'em



Teams are split onto different tables with one player from each team in each of the different seat positions



All players start each hand with an equal number of chips and receive their cards on a digital device.



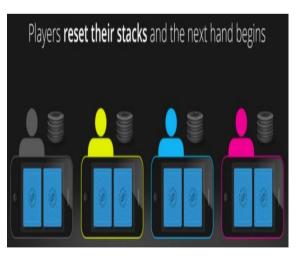
The same cards are dealt at all tables This means that every player in seat 1 (each from a different team) has identical cards. The same is true in every other seat



Each team's combined chips are compared after every hand and points allocated accordingly.



All action is recorded electronically enabling realtime automated scoring, animated replay and detailed analysis.



Players reset their stacks and the next hand begins.

After a pre-determined number of hands the team with the most points wins

MATCH IPL

SEASON ONE

- The In-augral season was held on November'17
- Season-1 was an action packed two day event held in Mumbai
- Seven teams representing different cities from across the countries spent two days competing for prize money totalling Rs 25 mn
- Winning team Mumbai All Stars, represented India at the Match Poker World Cup held in Oxford later in December



SEASON TWO

- Season-2 of Match-IPL was concluded on March 31st, 2018
- Season-2 witness 10 teams, wherein 3 new teams were added in season 2 at 50% higher franchisee fees
- Ten teams representing different cities from across the countries spent two days competing for prize money totalling Rs 9 mn
- The Event was aired on MTV in the month of April
- Winning team, team Haryana, represented India at the Match Poker Asia Cup held in Bangkok
