Independent Auditor's Report

To the Board of Directors of MODELLA WOOLLENS LIMITED

Report on the audit of the Annual Financial Results

Opinion

We have audited the accompanying quarterly financial results of MODELLA WOOLLENS LIMITED ('the company') for the quarter ended March 31,2024 and the year to date results for the period from 01st April 2023 to 31st March 2024, attached herewith, being submitted by the Company pursuant to the requirements of regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulation').
