INDIA SUPPORTS BHUTAN IN HEALTHCARE

Modi unveils India-funded hospital

150-bed hospital built at a cost of ₹141crore

PRESS TRUST OF INDIA Thimphu, March 23

PRIME MINISTER NARENDRA Modi and his Bhutanese counterpart Tshering Tobgay on Saturday inaugurated a hospital built with Indian assistance which will offer quality healthcare for women and children and be a shining example of India-Bhutan development cooperation. The Gyaltsuen Jetsun Pema Wangchuk Mother and Child Hospital is a state-of-the-art 150-bedded facility that has been built with the assistance of

the Government of India in Thimphu. "Inaugurated the Gyaltsuen Jetsun Pema Wangchuck Mother and Child

Hospital, which stands as a beacon of hope for several families, offering quality healthcare," Modi posted on X.

He said the new facility embodies a commitment to nurturing a healthy future generation. "A boost to partnership in healthcare.PM@narendramodi together with PM @tsheringtobgay of Bhutan inaugurated the Gyaltsuen Jetsun Pema Mother and Child Hospital in Thimphu.

The state-of-the-art hospital is a shining example of India-Bhutan development cooperation," external affairs ministry spokesperson Randhir Jaiswal said in a post on X. India has supported the development of the hospital in two phases. The first phase was constructed at a cost of ₹22 crore and has been operational since 2019. The construction of the second phase was taken up in 2019, as part of the 12th Five Year Plan at a cost of ₹119 crore, and was completed recently, the Ministry of External Affairs said in a press release. It said that the newly constructed hospital would add value to the quality of mother and child health services in Bhutan. The new facility will house state-ofthe-art facilities for Pediatrics, Gynaecology and Obstetrics, Anesthesiology, Operation Theatre, Neonatal Intensive Care and

Pediatric Intensive Care. "The Hospital stands as a shining example of India-Bhutan partnership in health care," it added." Bhutan has been receiving a lot of support from India, especially in the health sector, starting from the three referral hospitals and also other health facilities," Bhutan health minister Tandin Wangchuk told PTI.

Pak is sponsoring terrorism at 'industry level': Jaishankar PRESS TRUST OF INDIA

UNDERLINING THAT PAK-**ISTAN** is sponsoring terrorism at almost an "industry level", external affairs minister S Jaishankar on Saturday asserted that the mood in India now is not to overlook terrorists and it "will not skirt this problem anymore". Jaishankar, who is on a three-

day visit to Singapore, made these remarks during a Q&A round held post his lecture session on his authored book Why Bharat Matters at Institute of South Asian Studies (ISAS) of National University of Singapore (NUS). "Every country wants a stable neighbourhood...if nothing else, you want at least a quiet neighbourhood," he said in response to a question on India's ties with Pakistan. However, unfortunately, it is not the same with India, he said. Underlining that Pakistan

has been sponsoring terrorism against India, Jaishankar asked,"How do you deal with a neighbour who does not hide the fact that they use terrorism as an instrument of statecraft?""It's not a one-off happening...but very sustained, almost at an industry level...So what we have come to conclude is that we have to find a way of addressing (the menace), that dodging the problem gets us nowhere, it only invites more trouble," he said. "I don't have a quick instantaneous fix (to this issue). But what I can tell you is that India will not skirt this problem anymore. We are not going to say, 'well, that happened and let's continue our dialogue'...we have a problem and we must be hon-



est enough to face up to that problem, however difficult it is...we should not give the other country a free pass, saying there's nothing they can do about it or it's a very hard problem, or there's so much else at stake that let us overlook," he asserted. In India now, Jaishankar said,"the mood is not to overlook terrorists". Ties between India and Pakistan strained after a terror attack on the Pathankot Air Force base in 2016 by terror groups based in the neighbouring country. India's non-alliance culture enables to balance relations with both Russia, US

Dr S Jaishankar described India's relationship with Russia

and the US as a "multi-vector" policy and said it was possible to deal with each one on a "nonexclusive"basis because of India's strong non-alliance culture. On his three-day visit to Singapore, he said, "On Russia-US, when I said multi-vector policy today, this is something which every, certainly every significant country is going to face. Which is, if you have conflicting interests, if you have different partners, if you are vested in relationships, which often appear to be at cross purposes with each other, how do you actually reconcile this? "And the answer is clearly, to find ways by which each one of them is dealt with on a non-exclusive basis," Jaishankar said.

US Senate passes \$1.2-trillion funding package, ending threat of a partial shutdown

THE SENATE PASSED a \$1.2 trillion package of spending bills in the early morning hours on Saturday, a long overdue action nearly six months into the budget year that will push any threats of a government shutdown to the fall.

The bill now goes to President Joe Biden to be signed into law.The vote was 74-24.It came after funding had expired for the agencies at midnight, but the White House sent out a notice shortly after the deadline announcing the Office of Management and Budget had ceased

"Because obligations of federal funds are incurred and tracked on a daily basis, agencies will not shut down and may continue their normal operations," the White House statement said.

Prospects for a short-term government shutdown had appeared to grow Friday evening after Republicans and Democrats battled over proposed amendments to the bill. Any successful amendments to the bill would have sent the legislation back to the House, which had already left town for a two-

week recess. But shortly before midnight Senate Majority Leader Chuck Schumer announced a breakthrough. "It's been a very long and difficult day, but we have just reached an agreement to complete the job of funding the government," Schumer said.

China's claims on Arunachal 'ludicrous': Jaishankar

EXTERNAL AFFAIRS MINISTER S Jaishankar dismissed China's repeated claims on Arunachal Pradesh as "ludicrous" and asserted that the frontier state was a "natural part of India". In probably his first public comments on China's frequent claims on Arunachal Pradesh and its opposition to Indian leaders visiting the state, Jaishankar said it was not a new issue. "I mean China has laid claim, it has expanded its claim. The claims are ludicrous to begin with and remain ludicrous today,"he said in response to a question on the Arunachal issue after delivering a lecture at the prestigious Institute of South Asian Studies (ISAS) of the National University of Singapore (NUS) in Singapore.

Jaishankar said the challenge for India today is how to find the sustainable equilibrium between two rising powers, who also happen to be neighbours, and who have a history and a population, which sets them apart from the rest of the world and who also have capabilities.

He also said it came as a "great surprise" to India when the Chinese in 2020 "chose to do something on the border, which was completely violative of agreements we had reached".

जनसत्ता ब्यूरा नई दिल्ली, 23 मार्च।

भारतीय जनता पार्टी (भाजपा) ने शनिवार को कहा कि कांग्रेस के पास कई बैंक खाते हैं तथा कर बकाए का भगतान नहीं करने को लेकर उनमें से महज तीन-चार खाते कुर्क किए गए हैं न कि उन्हें 'फ्रीज' किया गया है। भाजपा ने साथ ही कांग्रेस पर लोकसभा चुनाव में अपनी तय हार को भांपकर इस मुद्दे पर भ्रामक बयान देने का आरोप लगाया।
