Sub: Inadvertent Trading by a Designated Person

This is to inform you about an inadvertent trade done by a Designated Person, Mr Pankaj Mota who is designated as the Chief Commercial Officer (West & South) of the Company. Mr Pankaj Mota had inadvertently traded in the shares of the Company during the window closure period. He bought 5000 shares and subsequently sold same number of shares without obtaining pre-clearance.

The Audit Committee of the Company was notified of the matter. Based on Mr Pankaj Mota's submission, the Audit Committee at its meeting held on 22nd October 2020 has concluded that this was an inadvertent trade made without intent to violate the Company's Insider Trading Code or the SEBI (Prohibition of Insider Trading) Regulations, 2015 ("PIT Regulations").

However, the Audit Committee has determined that there was a violation of the Company's Insider Trading Code and PIT Regulations and has therefore imposed on Mr Mota, a penalty of Rs.1,00,000 and also disgorging of the profits from the trade, the amount of which will be remitted to the Investor Protection Education Fund (IPEF) in line with the PIT Regulations
