Bharat Financial Inclusion Limited registers 45% YoY growth in Gross Loan Portfolio to Rs. 16,651 crore in Q3-FY19

Healthy customer addition of 9.2 lakh in Q3-FY19 contributes significantly to Gross Loan Portfolio growth.

Mumbai, January 29, 2019: Bharat Financial Inclusion Limited, the largest microfinance company in India, today announced a 45% year-on-year growth (8% quarter-on-quarter growth) in its Gross Loan Portfolio to Rs.16,651 crore in Q3-FY19 (Rs. 11,447 crore in Q3-FY18; Rs. 15,482 crore in Q2-FY19).

Bharat Financial Inclusion Limited registered a 29% year-on-year growth in the number of customers to 85.3 lakh (from 66.3 lakh customers in Q3-FY18).

"Bharat Financial Inclusion Limited's sustainable growth of Gross Loan Portfolio through healthy customer acquisition remains intact. The customer base saw an addition of 9.2 lakh customers in Q3-FY19." said M.R. Rao, CEO and Managing Director, Bharat Financial Inclusion Limited.

The Company's loan disbursements have shown a 45% year-on-year growth to Rs. 6,822 crore in Q3-FY19 (Rs. 4,712 crore in Q3-FY18).

Bharat Financial Inclusion Limited recorded a 140% year-on-year growth in incremental drawdowns to Rs. 5,510 crore in Q3-FY19 (Rs. 2,293 crore in Q3-FY18) including three assignment transactions and an equal number of securitization transactions amounting to Rs. 2,511 crore and Rs. 937 crore respectively in Q3-FY19. The Company also originated Rs.1,437 crore under managed portfolio in Q3-FY19.

The Company's cost to income improved substantially and was at a historical low of 34.4% based on Ind AS (39.6% based on per previous GAAP) in Q3-FY19.

The Company had a gross NPA of 0.6%, while Net NPA stood at 0.2% in Q3-FY19.

The Company had a net worth of Rs. 3,903 crore and a capital adequacy of 36.2% as of December 31, 2018 (compared to the RBI requirement of 15% capital adequacy). Cash and cash equivalent stood at Rs. 1,522 crore as of December 31, 2018.

As per Ind AS, Bharat Financial Inclusion Limited's profit after tax for Q3-FY19 registered a 49% year-on-year and 24% quarter-on-quarter growth to Rs. 288 crore (Rs. 193 crore in Q3-FY18 and Rs. 233 crore in Q2-FY19). As per Ind AS, profit after tax for 9M-FY19 is Rs. 663 crore (Rs. 645 crore as per Previous GAAP). As per previous GAAP, profit after tax for Q3-FY19 is Rs. 243 crore (Rs. 163 crore in Q3-FY18 and Rs. 212 crore in Q2-FY19).
