Subject: - Non applicability of provisions of Regulation 27 of SEBI, LODR 2015 on James Hotels Ltd.

Dear Sir/Madam

This is with reference to your letter no 526558/812/2018-19 for Non- Submission of Corporate Governance Report under Regulation 27(2) of the SEBI (LODR) Regulations, 2015 for two consecutive quarters i.e. March 2018 and June 2018.

In this regard we would like to again submit that the company is undergoing Corporate Insolvency Resolution Process under Insolvency and Bankruptcy Code, 2016. The matter is subjudice and pending before various forums including Hon'ble Supreme Court and Hon'ble Punjab & Haryana High Court. As IBC proceedings are initiated and the Board of directors of the company as well as all committees thereof is suspended.

Furthermore I would also like to clarify here that from the records of the company which is available with me I hereby submit that the provisions of Regulation 27 regarding applicability of Corporate Governance report as per LODR-2015 are not applicable to the company pursuant to the exemption granted under Chapter IV

Furthermore the company was transferred to Z group due to nonpayment of penalty for non filing of corporate governance report under regulation 27(2) of SEBI (LODR) Regulation 2015, you are requested to restore the company from Z group to the group as earlier. Accordingly promoters holding shall not be freezed for the same reason as company has not made any default.
