I, Vishal Kumar Garg, Proprietor of M/s. Vishal Garg & Associates, Company Secretaries, have been appointed as Scrutinizer for the purpose of the scrutinizing the **VOTING PROCESS** in a fair and transparent manner & ascertaining the requisite majority on **VOTING** carried out as per the provisions of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, ("Rules") on resolution(s) as mentioned in the Postal Ballot Notice dated 02nd March, 2021 during the Voting period from 05th March, 2021(09.00 A.M. - The Company has informed me that, in terms with the provisions of the General Circular number 39/2020, 14/2020, 17/2020 & all other applicable laws and circulars issued by the Ministry of Corporate Affairs (MCA) and Securities and Exchange Board of India (SEBI), the Physical dispatch of Postal Ballot Notice is dispensed with and all the items being considered through Postal Ballot are to be considered only through e-voting mechanism till 30th June, 2021. Accordingly the Company has provided to its shareholders the facility of evoting for casting their votes.
- The Company has completed on 05th March, 2021 the dispatch of Notice of Postal Ballot via Email to its members whose name(s) appears on the List of Members/List of Beneficiaries as on 26th February, 2021
- The shareholders holding shares as on the "cut off" date i.e. 26th February, 2021 were entitled to vote on the proposed resolution as set out in the Postal Ballot Notice of M/s. SDC Techmedia Limited dated 02nd March, 2021.
- The E-Voting period remained open from 05th March, 2021 (09.00 A.M. IST.) to 03rd April, 2021 (05.00 P.M. IST.).
