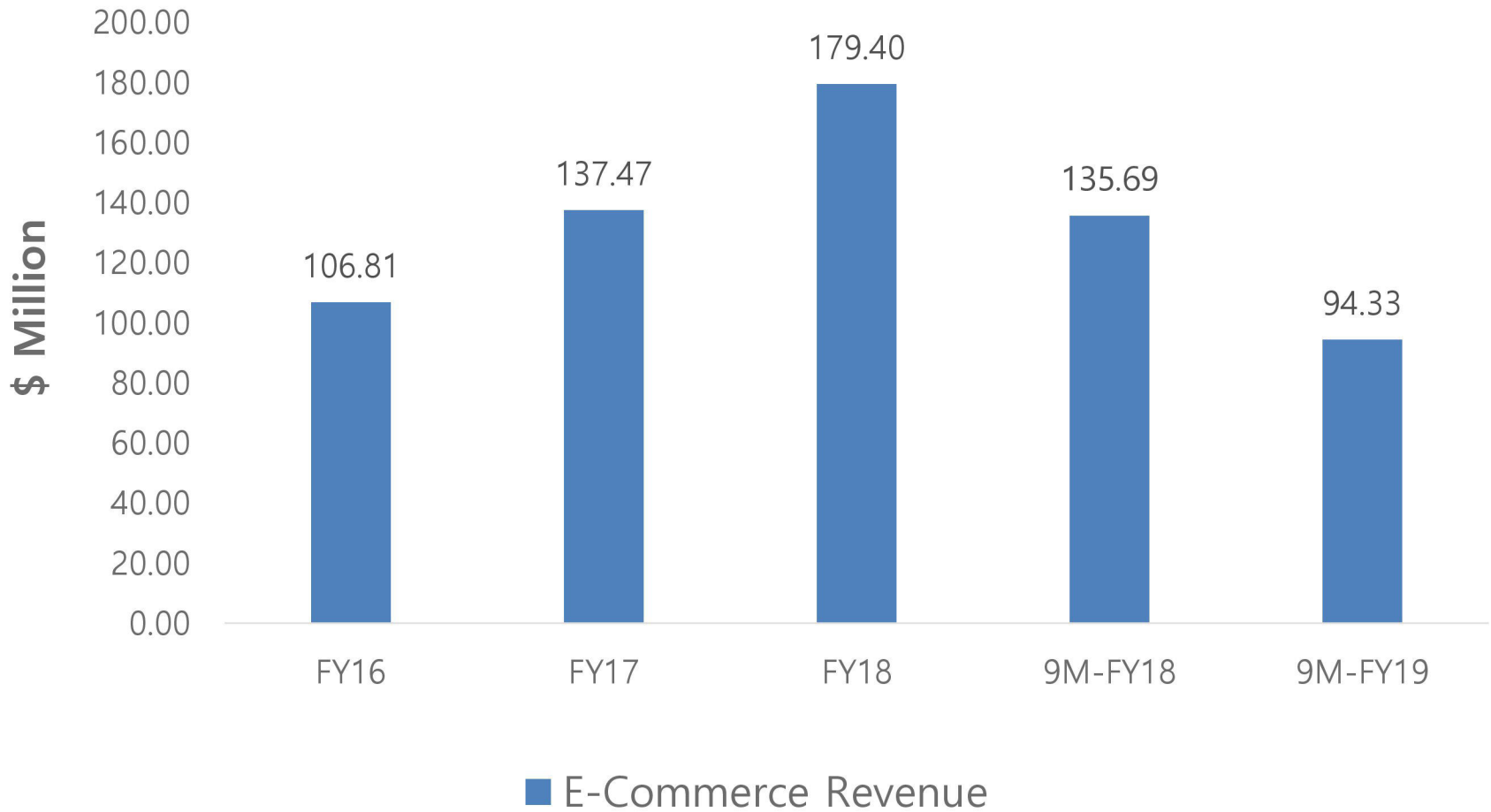

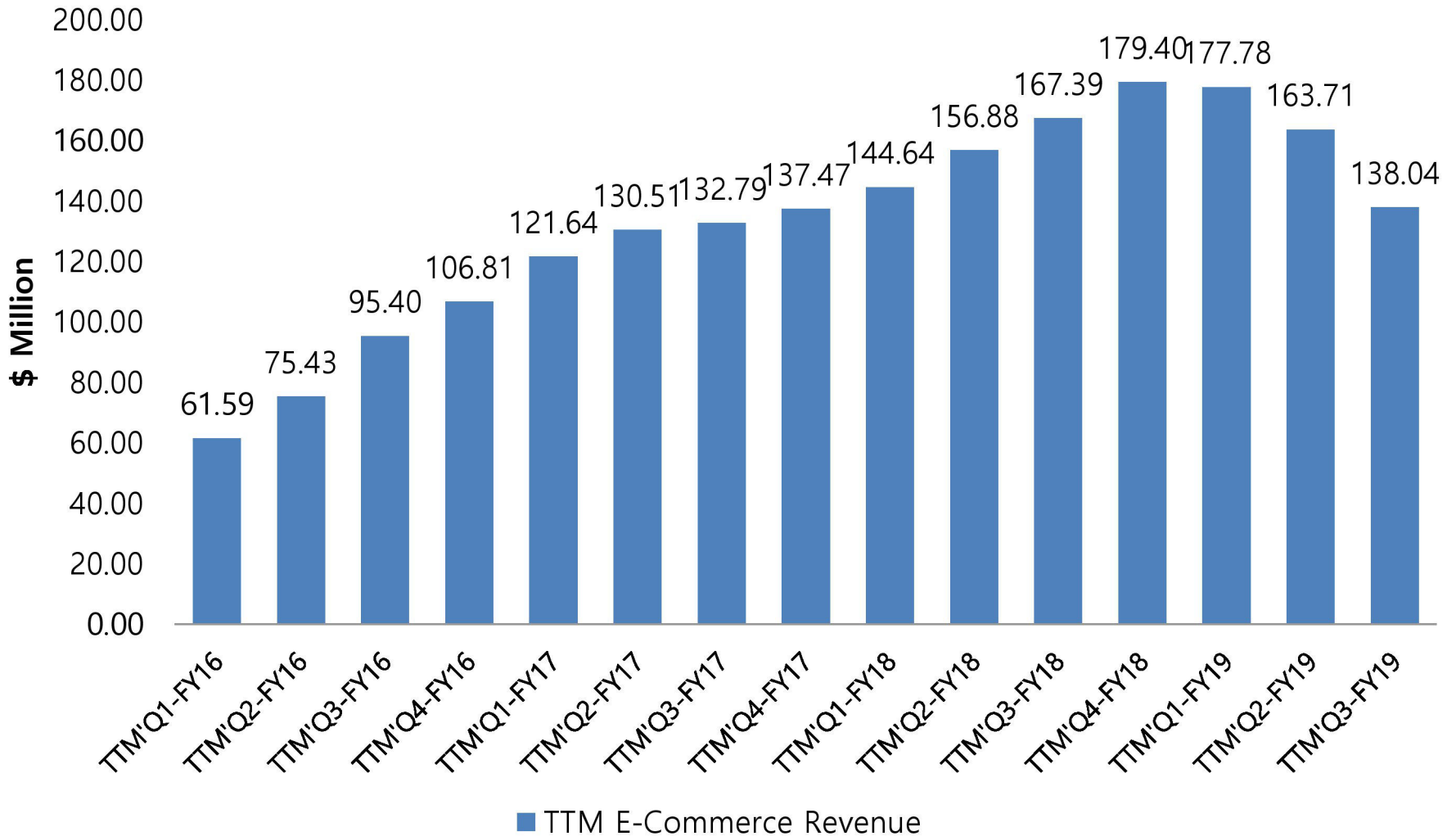


E-Commerce Revenue Trend





E-Commerce Revenue Trend

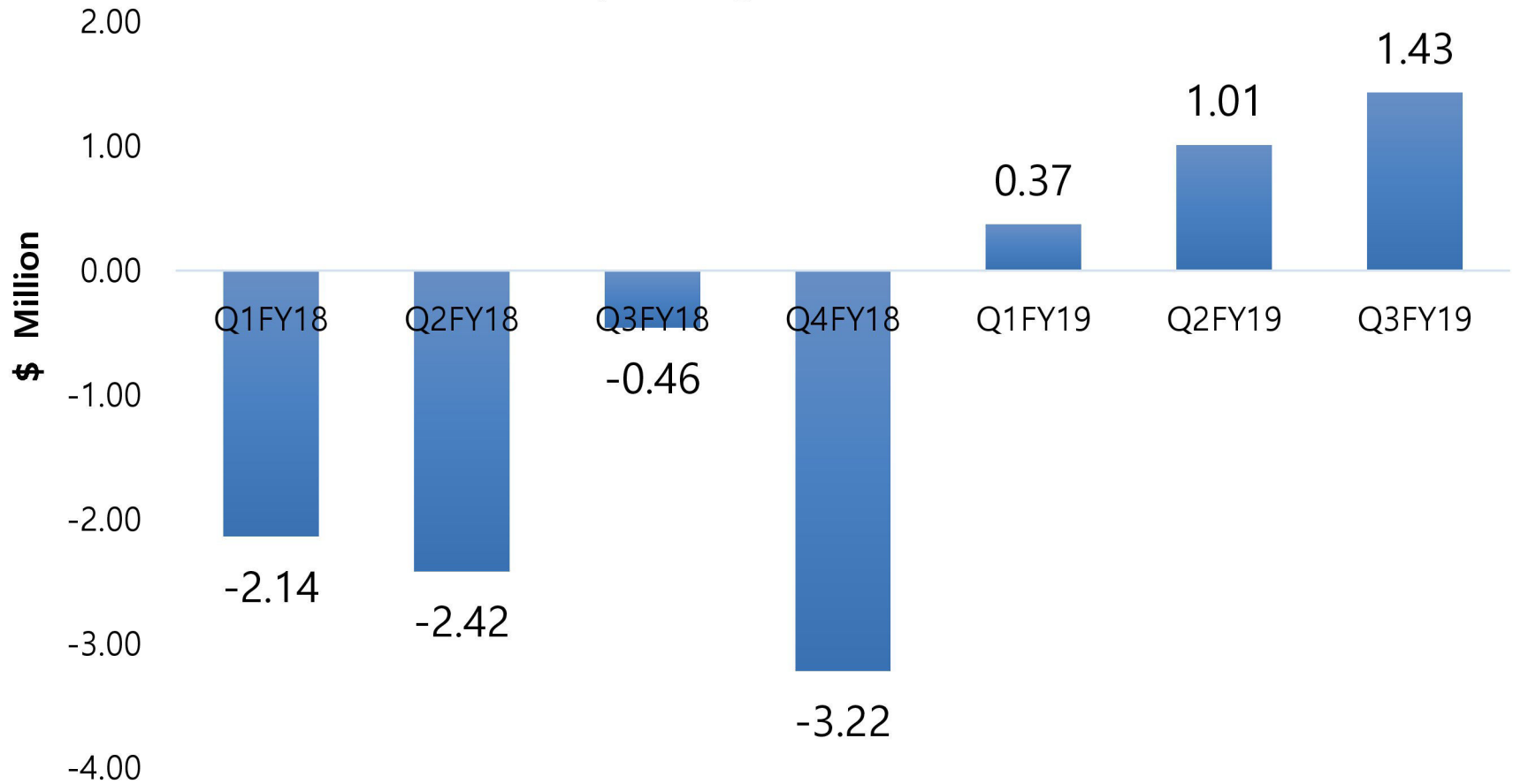


TTM refers to Trailing Twelve Months
