We are writing pursuant to Regulation 30 of the Listing Regulations, and in reference to the Stock Exchange ('SE') intimation dated September 21, 2023 and March 27, 2023. We wish to update that, we have received the Demand Notice under Rule 50 of the Drone Rules 2021 bearing the File No. DGCA/-31051/2/2023-DRONE dated April 08, 2024, in view of the order issued vide File No. AV-29011/9/2024-SDIT-MoCA dated March 26, 2024, directing the Company to deposit the penalty amount of Rs. 10,000/- in the Bharatkosh portal. This notice further states that the Demand Notice vide DGCA Order vide File No. DGCA-31051/2/2023 – DRONE- dated September 20, 2023 has been withdrawn.

As per the directions of the DGCA, the Company has deposited the penalty amount of Rs. 10,000/- with the DGCA.

In this regard, we hereby enclose the necessary details of this regulatory action as required under the Listing Regulations, in accordance with SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 09, 2015. Please find the details attached as **Annexure – A**.

This pertains to the transfer of our Q6 UAS to Flying Technology Solutions Pvt Ltd. We have submitted our detailed response by Reply dated June 07, 2023 (“Reply”) to the DGCA, highlighting the unique roles of manufacturers and operators in the drone ecosystem. We had requested the DGCA to reconsider the reported violations and revoke the proposed action. However, by order dated September 20, 2023, the Ld. DGCA authority found the Reply unsatisfactory and charged Rs. 1,00,000/- (Rupees One Lakh only) as monetary penalty.</p> <p>The Company subsequently filed an Appeal on October 18, 2023, under Section 10A of the Aircraft Act, 1934, against DGCA's order dated September 20, 2023. The Secretary of MoCA later issued an order vide No. AV-29011/9/2024-SDIT-MoCA dated March 26, 2024, reducing the penalty amount to Rs. 10,000/-.</p> <p>The Director General of Civil Aviation (DGCA) issued a demand notice directing the Company to deposit the penalty amount of Rs. 10,000/-</p>
