### To Board of Directors of Anmol India Limited

- We have reviewed the accompanying statement of unaudited financial results ('the Statement') of Anmol India Limited ('the Company') for the quarter ended 31 December 2023 and the year to date results for the period 01 April 2023 to 31 December 2023 being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended ('the Listing Regulations').
- 2.
