SUMMARY OF PROCEEDINGS OF THE EXTRA ORDINARY GENERAL MEETING OF

INTER GLOBE FINANCE LIMITED

The Extra Ordinary General Meeting ("EGM") of the Members of INTER GLOBE FINANCE LIMITED (the "Company") was held on Monday, March 18, 2024 at 2:00 P.M. (IST) through Video Conferencing ('VC') facility. The Company, while conducting the Meeting, adhered to the circulars issued by the Ministry of Corporate Affairs ('MCA'), the Securities and Exchange Board of India ('SEBI'). The said EGM commenced at 02:00 P.M (IST) and concluded at 02:18 P.M (IST).

Mr. Navin Jain- Managing Director of the Company chaired the Meeting and welcomed the Members of the Company and briefed them on certain points relating to the participation at the Meeting through VC. The Chairman informed that the Company had provided its Members the facility to cast their vote electronically through the Central Depository Service (India) Limited ('CDSL') system before the Meeting. The Chairman also informed that the EGM Notice had been sent electronically to those members whose email id's were registered with the Company/RTA or Depository Participants.

The requisite quorum being present, the Chairman called the Meeting to order. The Registers as required under the Companies Act, 2013 were available for inspection. Since there was no physical attendance of Members, the requirement of appointing proxies was not applicable.

The representatives of M/s JLN US & CO. Statutory Auditors and M/s. Isha Bothra & Associates Secretarial Auditors were also present at the Meeting through VC.

The Company Secretary informed that the facility for remote e-voting commenced at 9:00 A.M. (IST) on Friday, 15th March, 2024 and concluded at 5:00 P.M. on Sunday, 17 March, 2024. She also informed that voting by electronic means was also available during the EGM to those shareholders who had not already voted by means of remote e voting. She further informed to the Shareholders that Mr. Satyajit Mishra Practicing Company Secretary (Membership No. FCS 5759/ CP No. 4997) from M/S. Satyajit Mishra and Co., was appointed as the scrutinizer to scrutinize the voting through electronic means (i.e. remote e-voting and voting at the meeting by using electronic system) in a fair and transparent manner.

Thereafter, the Notice convening the EGM of the Company was taken as read by the Chairman, with the consent of the Members present. The Chairman then announced that



the e-voting facility was open and Members may visit the voting page of CDSL e-voting website and cast their vote.

The following items of business, as per the Notice convening the EGM of the Company dated February 21, 2024 were considered and passed at the EGM:

The Chairman then invited the Members to express their views, ask questions and seek clarifications on the operations and financial performance of the Company and on the resolutions set out in the Notice convening the EGM of the Company. The Members were given an opportunity to speak in the order in which they had registered their names. The Chairman appropriately responded to the queries/suggestions raised by them.

The Chairman informed the Members that the combined results of the remote e-voting before / during the EGM would be announced within the stipulated time frame and the results along with the Scrutinizers Report would be intimated to the stock Exchanges www.bseindia.com in terms of the Listing Regulations and would be placed on the websites of the Company www.igfl.co.in and CDSL www.evotingindia.com.

The Chairman then thanked the Members for their continued support and for attending and participating in the meeting. He also thanked the Directors for joining the Meeting. The e-voting facility was kept open for the next 30 minutes to enable the Members to cast their vote. Upon completion of the e-voting process the Company Secretary declared the Meeting as concluded.
