Sub: Scrutiniser's Report on the 10<sup>th</sup> Postal ballot conducted under Section 110 of the Companies Act, 2013 ("the Act") read with Rule 22 of the Companies (Management and Administration) Rules, 2014

I have, vide a resolution passed by your Board of Directors on 4th February 2021, been **appointed to act as the Scrutiniser** for the Company's **Tenth Postal Ballot** process, which was initiated to obtain the approval of your members by way of **special/ordinary resolution(s)** for **three** items of business as set out below:

#### Business transacted through the 10th Postal Ballot

- Approval of Re-appointment of Sri Suresh Krishna (DIN: 00046919), as Chairman and Non-Executive Director and payment of remuneration for a period of 5 years from July 1, 2021 to June 30, 2026 (Special Resolution).
- 2. Approval of remuneration payable to Sri Suresh Krishna (DIN: 00046919), Chairman and Non-Executive Director for the financial year ending March 31, 2022, which may exceed 50% of the total annual remuneration payable to all Non-Executive Directors for the said financial year, pursuant to Regulation 17(6)(ca) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Special Resolution).
- Approval of Re-appointment of Ms. Arathi Krishna (DIN: 00517456) as Managing Director and payment of remuneration for a period of 5 years from May 3, 2021 to May 2, 2026 (Ordinary Resolution).

#### I submit my report as under:

1. The Company is a listed company with the equity shares being listed with the National Stock Exchange of India Limited (NSE) and the BSE Limited (BSE).

## Sundram Fasteners Limited – 10th Postal Ballot – 15th February 2021 to 16th March 2021 Scrutiniser's report

- The Company selected National Securities Depository Limited (NSDL), as the agency to provide
  the e-voting platform for the remote e-voting process. NSDL allotted E-voting Event Number
  (EVEN) 115689 for the Company's 10<sup>th</sup> Postal Ballot.
- 5th February 2021 was fixed by your Board as the cut-off date for determining the members
  who were eligible to vote through remote e-voting and the number of votes each of them could
  exercise.
- 4. Notice of the 10<sup>th</sup> Postal Ballot was sent/ filed **on 15<sup>th</sup> February 2021, to / with various persons/entities and in the manner set out below**:
  - (a) **Through e-mail** (sent by NSDL) to 49,891 members whose e-mail address were registered with the Company/Depositories, out of the total of 58,803 members (including shares lying in the Sundram Fasteners Limited Unclaimed Suspense Account) as on 5th February, 2021. Physical postal ballot forms were not dispatched to the members in view of the relaxation granted by the Ministry of Corporate Affairs vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020 read with Circular No. 33/2020 dated September 28, 2020 and Circular No. 39/2020 dated December 31, 2020 ("MCA Circulars"). The Company has placed the Notice of Postal Ballot on its website.
  - (b) Filed online with the **NSE** and **BSE** in terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (**LODR**).
  - (c) Sent by email to all the Auditors, Secretarial Auditors and Cost Auditor of the Company.
  - (d) Sent by e-mail to all the **Directors** of the Company.
- 5. The Notice and prescribed particulars about the remote e-voting process were duly **advertised on 16<sup>th</sup> February 2021** in Business Standard (in English) and Makkal Kural (in Tamil).
- 6. The voting period was from 9.00 A.M. on 15th February 2021 to 5:00 P.M. on 16th March 2021.
- 7. Integrated Registry Management Services Private Limited, your Share Transfer Agents (RTA), provided the details of the members who held shares on the cut-off date and accordingly were eligible to participate in the postal ballot.
- 8. The Company's paid-up equity share capital **as on the cut-off date** consisting of 21,01,28,370 equity shares of ₹1/- each, which was held by 58,803 members included the following on which **voting rights were frozen as per Regulation 39 read with Schedule VI of LODR:** 
  - (a) 8,09,811 equity shares in Sundram Fasteners Limited Unclaimed Suspense Account; and
  - (b) 10,15,627 equity shares on which dividend had not been claimed for seven consecutive years and transferred to and held by the Investor Education and Protection Fund Authority Ministry Of Corporate Affairs (IEPF) as per Section 124 of the Act.
- 9. **After 5.00 P.M. on 16th March 2021,** I unblocked the votes cast through **remote e-voting** in the presence of two witnesses not in the employment of the Company and obtained the remote e-voting report from the e-voting website of NSDL.

- 10. The votes cast through remote e-voting were validated with the list of members and their holding as on the cut-off date.
- 11. I also noted that no voting rights were exercised in respect of any of the 8,09,811 equity shares lying in Sundram Fasteners Limited Unclaimed Suspense Account in terms of LODR as well as 10,15,627 held by IEPF in terms of the Act.
- 12. I have recorded particulars of the votes cast through remote e-voting in a separate register maintained in electronic form.
- 13. A total of 411 members participated in the remote e-voting process and all the votes were considered as valid.
- 14. The results of the 10th postal ballot process (remote e-voting) are as under:
