Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 and other applicable clauses of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform that the Reserve Bank of India (RBI) had imposed a monetary penalty of Rs.10,000/- (Rupees Ten thousand only) on our Bank on account of a deficiency observed in one of our Branches viz., Kandri Branch, Kanhan Nagpur, Maharashtra in providing the exchange facility for the soiled/mutilated notes to noncustomers as prescribed by RBI vide RBI Master Direction No. RBI/2023-24/97 DCM (NE) No. G-2/08.07.18/2023-24 dated April 3, 2023.

While the Bank has laid down adequate procedures to ensure compliance with this regulatory requirement across its branches, the procedural lapse leading to deficiency in providing the exchange facility at the said branch is being investigated for necessary action to ensure that such incident do not recur.
