This is in continuation to our letter dated December 29, 2023, wherein we had informed about the extension of timeline till March 31, 2024, for completion of the sale of entire 25,65,103 equity shares of Rs. 10/- each, held by the Company (along with its nominees), representing 50.002% of the issued and paid-up share capital of Aditya Birla Insurance Brokers Limited ('ABIBL') to Edme Services Private Limited ("Purchaser"), pursuant to the share purchase agreement ("SPA") executed between the Company, ABIBL, Infocyber India Private Limited ("Infocyber", the other shareholder of ABIBL) and the Purchaser ("Proposed Transaction").

We would like to further update that since the conditions precedent, including the receipt of approval from Insurance Regulatory Development Authority of India for the completion of Proposed Transaction is still underway, the parties to the SPA on March 28, 2024, have mutually agreed to extend the timeline for completion of the Proposed Transaction till June 30, 2024.
