Outcome of Board Meeting

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulations, 2015, we would like to inform that upon receipt of requisite approvals, the Board of Directors of the Company in continuation of allotment of 26,00,755 CCDs in its previous meeting held on December 28, 2023 has further allotted 16,11,482 at a price of Rs. 102.50/- to the below mentioned allottees and raised an amount of Rs. 16,51,76,905/- (Rupees Sixteen Crores Fifty One Lakhs Seventy Six Thousands Nine Hundreds and Five only) by passing the resolution of allotment by circulation on January 1, 2024 and completed the allotment of 42,12,237 CCDs carrying an interest at the rate of 12% per annum payable on half yearly basis on Preferential Basis. The 2,00,600 CCDs were not subscribed by the proposed allottees. The details of allottees of 16,11,482 CCDs are as under:

The amount paid against Warrants shall be adjusted / set-off against the issue price for the resultant Equity Shares.
