Sub: Reduction of Penalty imposed by DGCA - Disclosure under Regulation 30 of Securities Exchange Board of India (Listing Obligations and Disclosure Requirements), Regulations 2015 ('Listing Regulations')

Dear Sir/Ma'am,

We are writing pursuant to Regulation 30 of the Listing Regulations, and in reference to the Stock Exchange ('SE') intimation dated September 21, 2023, wherein the Company disclosed to the SE about the penalty imposed by DGCA amounting to Rs. 1,00,000/- (Rupees One Lakh only) for non-compliance with Rule 17 of the Drone Rules 2021 through DGCA order dated September 20, 2023. In this regard, we further want to inform you that the Company had filed an Appeal on October 18, 2023, pursuant to Section 10A of the Aircraft Act, 1934, against the DGCA's order dated September 20, 2023.

We are pleased to announce the success of our appeal, wherein the Secretary, Ministry of Civil Aviation ('MoCA'), provided an opportunity for a hearing on the matter. After carefully considering the Drone Rules 2021, our arguments, and explanations, the MoCA took a holistic view of the situation and issued Order No. AV-29011/9/2024-SDIT-MoCA dated March 26, 2024, reducing the penalty to Rs. 10,000/-. Our legal team is reviewing the order and we will decide further course of action based on their advice.

In this regard, we hereby enclose the necessary details of this regulatory action as required under the Listing Regulations, in accordance with SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 09, 2015. Please find the details attached as **Annexure – A**.

This pertains to the transfer of our Q6 UAS to Flying Technology Solutions Pvt Ltd. We have submitted our detailed response by Reply dated June 07, 2023 ("Reply") to the DGCA, highlighting the unique roles of manufacturers and operators in the drone ecosystem. We had requested the DGCA to reconsider the reported violations and revoke the proposed action. However, by order dated September 20, 2023, the Ld. DGCA authority found the Reply unsatisfactory and charged Rs. 1,00,000/- (Rupees One Lakh only) as monetary penalty.
		The Company subsequently filed an Appeal on October 18, 2023, under Section 10A of the Aircraft Act, 1934, against DGCA's order dated September 20, 2023. The Secretary of MoCA later issued an order vide No. AV-29011/9/2024-SDIT-MoCA dated March 26, 2024, reducing the penalty amount to Rs. 10,000/ This is to inform you that this does not qualify as
